

## **ORDINANCE NO. 8514**

AN ORDINANCE FURTHERMORE AMENDING SECTION 1 OF ORDINANCE NO. 7987 AS AMENDED, BY INCLUDING THE VETERINARY INSPECTION BOARD'S VETERINARIANS, MEAT INSPECTORS, DOG CATCHERS AND OTHER ADMINISTRATIVE PERSONNEL, IN THE IMPLEMENTATION OF RELEVANT PROVISIONS OF REPUBLIC ACT 7305, OTHERWISE KNOWN AS THE MAGNA CARTA OF PUBLIC HEALTH WORKERS, SO AS TO PROVIDE RETIREMENT PAY, HAZARD ALLOWANCE, LONGEVITY PAY AND OVERTIME PAY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 1 of Ordinance No. 7987 is hereby furthermore amended to read as follows:

> "SECTION 1. The implementation of relevant provision of R.A. 7305, otherwise known as the Magna Carta of Public Health Workers, so as to provide for retirement pay, hazard allowance, longevity pay and overtime pay of Public Health Workers in the Manila Health Department and the five (5) City Government hospitals namely: the Ospital ng Maynila Medical Center, the Gat Andres Bonifacio Memorial Medical Center, the Ospital ng Sampaloc, the Ospital ng Tondo, the Clinic of Universidad de Manila (UDM) and the Veterinary Inspection Board's Veterinarians, Meat Inspectors, Dog Catchers and other Administrative Personnel, is hereby authorized".

SEC. 2. Effectivity Clause. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on December 15, 2016.
