## **ORDINANCE NO. 8517**

AN ORDINANCE AMENDING SECTION 2 AND SECTION 3 OF ORDINANCE NO. 8504, ENTITLED: "AN ORDINANCE AUTHORIZING THE ALLOCATION OF THE UNDER OPERATING EXPENSES, THE MAINTENANCE AND OPERATING EXPENSES THE OF MAINTENANCE AND OTHER DEPARTMENT OF INTERIOR AND LOCAL OFFICE. DEVELOPMENT GOVERNMENT - NATIONAL CAPITAL REGION, IN THE AMOUNT OF ONE (PHP. 120,000.00), TO BE USED AS HUNDRED TWENTY THOUSAND PESOS PAYMENT FOR THE ALLOWANCES OF THE CITY DIRECTOR", BY INCLUDING THE PAYMENT OF TRAVELLING ALLOWANCES FOR DILG PERSONNEL ASSIGNED IN MANILA, IN THE AMOUNT OF SEVEN HUNDRED TWENTY **THOUSAND PESOS (PHP. 720,000.00)**

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2 of Ordinance No. 8504 is hereby amended by including the payment of travelling allowances for DILG Personnel assigned in Manila, to read as follows:

- "SEC. 2. Pursuant to the stated policy, the following remunerations shall be provided:
  - a) Monthly allowance for the City Director (DILG-NCR) (PhP. 10,000.00 x 12 months)

PhP. 120,000.00

b) Monthly travelling allowance for thirty (30)
Officers and Staffs
(PhP. 2,000 x 12 months) x 30
Total
PhP. 720,000.00
PhP. 840,000.00"

- SEC. 2. Section 3 of Ordinance No. 8504 is hereby amended to read as follows:
  - "SEC. 3. The amount of Eight Hundred Forty Thousand Pesos (PhP. 840,000.00), is hereby authorized and allocated, to be sourced and taken from the Non-Office (Statutory and Contractual Obligations) funded under Ordinance No. 8442, FY 2016, to be used as payment for the allowances of the City Director (DILG-NCR) and travelling allowance for Thirty (30) Officers and Staff, in accordance with the accounting and auditing rules and regulations."
- SEC. 3. Effectivity Clause. This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 12, 2017.
