**ORDINANCE NO. 8523**

**AN ORDINANCE** PROVIDING FOR A GRANT OF SEVEN HUNDRED SIXTY PESOS (PhP. 760.00) MONTHLY ALLOWANCE TO TWO HUNDRED THIRTY-SIX (236) BUREAU OF JAIL MANAGEMENT AND PENOLOGY PERSONNEL COVERING THE PERIOD OF JANUARY TO DECEMBER 2017, FOR A TOTAL AMOUNT OF TWO MILLION ONE HUNDRED FIFTY-THREE THOUSAND PESOS (PhP. 2,153,000.00) PER ANNUM

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** It is the declared policy of the City Government of Manila when its finances so allow, to provide allowances and benefits to officials of the National Government stationed in or assigned to the city, aimed at strengthening their capabilities towards the delivery of effective and necessary services to the people of Manila.

**SEC. 2.** Pursuant to the above stated policy, the following remunerations shall be provided to the two hundred thirty-six (236) Bureau of Jail Management and Penology personnel assigned to the City of Manila:


- a) Monthly allowance in the amount of Seven Hundred Sixty Pesos (PhP. 760.00) each.
- b) Total yearly allowance authorized in the total amount of Two Million One Hundred Fifty-Three Thousand Pesos (PhP. 2,153,000.00).

**SEC. 3.** The amount of Two Million One Hundred Fifty-Three Thousand Pesos (PhP. 2,153,000.00) is hereby authorized and allocated, to be sourced and taken from the Manila Peace and Order Council (MPOC) Intervention Programs under General Fund FY 2017, to be used as payment for the Monthly Allowances of two hundred thirty-six (236) Bureau of Jail Management and Penology personnel covering the period of January to December 2017, in accordance with the accounting and auditing rules and regulations.


**SEC. 4. Effectivity Clause.** – This Ordinance shall take effect immediately upon its approval.


