ORDINANCE NO. 8528

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 8528, ENTITLED: "AN ORDINANCE AUTHORIZING THE CITY MAYOR TO CAUSE THE ACQUISITION EITHER BY NEGOTIATION, EXPROPRIATION OR BY ANY LEGAL MEANS, OF THAT CERTAIN PARCEL OF LAND CONSISTING OF ONE THOUSAND TWO HUNDRED THIRTY ONE SQUARE METERS AND TWENTY-TWO SQUARE DECIMETERS (1,231,22 SQ. M.) MORE OR LESS, SITUATED AT CORCUERA AND BALTAZAR STREETS, BARANGAY 88, ZONE 7, DISTRICT I, TONDO, MANILA REGISTERED UNDER THE NAME OF GENEROSA QUEENIE M. SENGCO, MARRIED TO RONALD A. SENGCO, IN THE REGISTRY OF DEEDS FOR THE CITY OF MANILA, UNDER TRANSFER CERTIFICATE OF TITLE NO. 292110, FOR ACTUAL AND BONA FIDE RESIDENTS THEREAT, UNDER THE LAND-FOR-THE-LANDLESS PROGRAM OF THE CITY OF MANILA", BY SUBSTITUTING SECTION 2 THEREOF

Be it ordained by the City Council of Manila in session assembled


SECTION 1. Section 2 of Ordinance No 8473 is hereby amended and shall now read as follows:

"SEC. 2. The amount of ELEVEN MILLION THREE HUNDRED EIGHTY-SEVEN THOUSAND THREE HUNDRED FORTY PESOS (PHP. 11,387,340.00) or so much thereof, as may be necessary is hereby appropriated, out of unappropriated funds existing in the City Treasury, to be made available for the implementation of the Ordinance"


SEC. 2. Effectivity Clause. - This Ordinance shall take effect upon its approval.

Enacted by the City Council of Manila at its regular session on October 19, 2017.


