AN ORDINANCE PROVIDING FOR A MONTHLY FINANCIAL ASSISTANCE TO ALL MANILA FIRE DISTRICT PERSONNEL IN THE AMOUNT OF TWO THOUSAND FIVE HUNDRED PESOS (PHP. 2,500.00) AND PROVIDING FUNDS THEREFOR

PREAMBLE

WHEREAS, it is high time to recognize the invaluable contributions of the men and women of the Manila Fire District in the provision of fire suppression and various fire prevention activities in the City of Manila:

WHEREAS, not only have they proven their gallantry and dedication in their sworn duties, but they had also actively performed important roles in the safety of the community such as providing emergency medical and rescue service, as well as providing basic socio-civic activities such as water rationing, flushing operations, ugnayan sa barangay program, civil disturbance management operations and clean-up drives;

WHEREAS, the grant of financial assistance to the personnel of the Manila Fire District will boost the morale of the fire service and encourage them to work doubly hard in protecting the Manileños from the adverse effects of destructive fires: NOW, THEREFORE

Be it ordained by the City Council of Manila, in session assembled, THAT:

- **SECTION 1.** That all 473 personnel of the Manila Fire Department shall be given a monthly financial assistance in the amount of Two Thousand Five Hundred Pesos (PhP. 2,500.00) starting FY 2018.
- SEC. 2. The amount of Fourteen Million One Hundred Ninety Thousand Pesos (PhP. 14,190,000.00), is authorized to be appropriated from funds available and not otherwise appropriated in the current appropriation ordinance.
- SEC. 3. It is also hereby authorized that the financial assistance to be appropriated in the annual executive budget of the year following the enactment of this Ordinance.
- SEC. 4. All Ordinances or parts thereof inconsistent with this Ordinance or parts hereof are hereby repealed, amended or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on November 23, 2017.
