**ORDINANCE NO. 8538**

**AN ORDINANCE** AFFIRMING THE EXISTING TERRITORIAL JURISDICTION OF BARANGAY 666, ZONE 72, DISTRICT V, MANILA, WITH BOUNDARIES FROM P. BURGOS STREET, NATIONAL MUSEUM (FORMER LEGISLATIVE BUILDING), PLANETARIUM, AS WELL AS THE NORTHERN PART OF THE NATIONAL PARKS DEVELOPMENT COMMITTEE AREA, TO THE NORTH; TAFT AVENUE AND INCLUDING THE EASTERN PART OF NATIONAL PARKS DEVELOPMENT COMMITTEE AREA, TOURISM BUILDING, RIZAL PARK, ETC. TO THE EAST; UNITED NATIONS AVENUE TO THE SOUTH; AND MANILA BAY, MANILA OCEAN PARK AND THE WESTERN PART OF NATIONAL PARKS DEVELOPMENT COMMITTEE AREA SUCH AS QUIRINO GRANDSTAND, ARMY NAVY CLUB, MUSEO PAMBATA, SEAFOOD WHARF, ETC. TO THE WEST

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** This Ordinance affirms and defines the existing territorial jurisdiction of Barangay 666, Zone 72 of District V, Manila, with boundaries as follows: Barangay 666, Zone 72, District V, Ermita, Manila, is bounded from P. Burgos Street, National Museum (the former Legislative Building), Planetarium, as well as the northern part of the National Parks Development Committee Area, to the North; Taft Avenue and including the eastern part of National Parks Development Committee Area, Tourism Building, Rizal Park, etc. to the East; United Nations Avenue to the South; and Manila Bay, Manila Ocean Park and the western part of National Parks Development Committee Area such as Quirino Grandstand, Army Navy Club, Museo Pambata, Seafood Wharf, etc. to the West as per information from the maps of COMELEC – National Capital Region, which have been the basis of the election-related activities in the past and at present time.

**SEC. 2.** City Council Resolution No. 309, Series of 2017, is hereby affirmed.

**SEC. 3. *Transitory Provision.*** – All income, real property taxes, business taxes, governmental and corporate services of the aforesaid area, which is incidental to the passing of this Ordinance, shall be collected, delivered and performed by Barangay 666, Zone 72, District V, Manila.


**SEC. 4.** This Ordinance amends Ordinance No. 8368 and other existing Ordinances/Resolutions that are inconsistent with the intent of this Ordinance.

**SEC. 5. *Separability Clause.*** – If for any reason or reasons, any provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.


**SEC. 6. *Effectivity Clause.*** – This Ordinance shall take effect upon its approval.

Respectfully returned to the Office of the Vice Mayor, Hon. Sheilah H. Lacuna-Pangan; the within **Ordinance No. 8538** entitled "*An Ordinance affirming the territorial jurisdiction of Barangay 666, Zone 72, District V, Manila, with boundaries from P. Burgos Street, National Museum (former Legislative Building), Planetarium, as well as the northern part of the National Parks Development Committee area, to the North; Taft Avenue and including the eastern part of National Park Development Committee Area, Tourism Building, Rizal Park, etc.. to the East; United Nations Avenue to the South; and Manila Bay, Manila Ocean Park and the western part of National Parks Development Committee area such as Quirino Grandstand, Army Navy Club, Museo Pambata, Seafood Wharf, etc. to the West.*"

Subject Ordinance is substantially the same as **Ordinance 8534**, entitled "**An Ordinance declaring the territorial jurisdiction of Barangay 666, Zone 72, District V, Manila, with boundaries from Padre Burgos St., National Museum (former Legislative Building), Planetarium, as well as the northern part of the National Parks Development Committee, to the North; Taft Avenue and including the eastern part of National Park Development Committee, Tourism Building, Rizal Park, etc.. to the East; United Nations Avenue to the South; and Manila Bay, Manila Ocean Park and the western part of National Park Development Committee such as Quirino Grandstand, Army Navy Club, Museo Pambata, Seafood Wharf, etc. to the West as per information from the maps of COMELEC - National Capital Region, which the Honorable City Mayor vetoed on 22 December 2017 for being contrary to law.**"

Please note that **Sec. 385. (Manner of Creation) of the Local Government Code** provides that a barangay may be created, divided, merged, abolished, or its territorial jurisdiction substantially altered by law or by an ordinance of the sangguniang panlalawigan or sangguniang panlungsod, subject to **approval by a majority of the votes cast in plebiscite to be conducted by the Comelec in the local government unit or units** directly affected within such period of time as may be determined by the law or ordinance creating said barangay. In the case of the creation of barangays by the sangguniang panlalawigan, the recommendation of the sangguniang bayan concerned shall be necessary.
