## **ORDINANCE NO. 8540**

AN ORDINANCE AMENDING SECTIONS 3 AND 4 OF CITY ORDINANCE NO. 8513, ENTITLED: "AN ORDINANCE AUTHORIZING THE GRANT OF MONTHLY INCENTIVE ALLOWANCE TO ALL LAWYERS OF THE PUBLIC ATTORNEY'S OFFICE ASSIGNED/BASED IN THE CITY PROVIDING FREE LEGAL ASSISTANCE TO THE RESIDENTS THEREAT, APPROPRIATING ANNUALLY THE AMOUNT OF SEVEN MILLION TWO HUNDRED THOUSAND PESOS (PHP. 7,200,000.00) FOR THE PURPOSE"

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 3 of City Ordinance No. 8513, is hereby amended to read as follows:

"SEC. 3. Pursuant to the stated policy, the following remunerations shall be provided:

- SEC. 3-A. In case of promotion or other personnel movement that entails the increase in position/rank, the grant of said allowance/incentive to the Public Attorney concerned shall be automatically readjusted from the promotion of said Public Attorney takes effect, subject to the presentation of certain documents as proof of such movement to the Office of the City Mayor. The adjustment shall take place as of the time of said promotion provided it is within the allocated budget, as reflected in Section 2 of this Ordinance. Otherwise, the promoted Public Attorney shall maintain the monthly incentive allowance pertaining to his/her former position."
- SEC. 2. Section 4 of City Ordinance No. 8513, is hereby amended to read as follows:
  - "SEC. 4. The amount of Eleven Million Two Hundred Fifty-Six Thousand Pesos (PhP. 11,256,000.00), is hereby authorized and allocated, to be sourced and taken from the Non-Office (Statutory and Contractual Obligations) funded for the payment of the monthly incentive allowances to all lawyers of the Public Attorney's Office (PAO) assigned/based in the City of Manila providing free legal assistance to residents thereat."
- **SEC. 3.** Let a copy of this Ordinance be furnished to the Office of the City Treasurer, the Office of the City Accountant, the Office of the City Budget, the Public Attorney's Office-Manila for their information, guidance and reference.
- **SEC. 4.** Any provisions of this Ordinance or part hereof be declared invalid or without force or effect, the other provisions or parts not affected thereby shall remain valid and effective.
- **SEC. 5.** All ordinances and issuances, or portions thereof, which are inconsistent with the provisions of this Ordinance, are hereby repealed, amended, or modified accordingly.

SEC. 6. Effectivity Clause. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on February 15, 2018.
