

## ORDINANCE NO. 8542

**AN ORDINANCE** AUTHORIZING SUPPLEMENTAL BUDGET NO. 1, CALENDAR YEAR 2018, IN THE AMOUNT OF TWO HUNDRED FIFTY MILLION PESOS (PHP. 250,000,000.00)

Be it ordained by the City Council of Manila, in session assembled, THAT:

**SECTION 1. Authorization.** - Supplemental Budget No. 1, Calendar Year 2018, in the amount of Two Hundred Fifty Million Pesos (PhP. 250,000,000.00), to cover expenses for the provision for unforeseen expenditures, is hereby authorized, to wit:

**SEC. 2. Source of Funds.** – The funds necessary to execute this Ordinance as specified in Section 1 hereof in the amount of Two Hundred Fifty Million Pesos (PhP. 250,000,000.00), is hereby appropriated, and sourced from funds actually available as duly certified by the City Treasurer.

SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.
