ORDINANCE NO. 8543

AN ORDINANCE AMENDING THE OBJECT OF EXPENDITURES SPECIFIED IN PARAGRAPH (B) UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES IN THE PROGRAMMED APPROPRIATION AND OBLIGATION OF THE OFFICE OF THE SANGGUNIANG PANLUNGSOD, UNDER ACCOUNT CODE NOS. 5-02-11-030 AND 5-02-11-990, AUTHORIZED THROUGH ORDINANCE NO. 8530, ALSO KNOWN AS THE EXECUTIVE BUDGET FOR CALENDAR YEAR 2018

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Paragraph (b) under Maintenance and Other Operating Expenses of Ordinance No. 8530, under Account Code Nos. 5-02-11-030 and 5-02-11-990 in the Programmed Appropriation and Obligation by Object of Expenditures of the Office of the Sangguniang Panlungsod shall now be amended to be covered and lumped exclusively under Account Code No. 5-02-11-030, for consultancy services in the amount of Ten Million Pesos (PhP. 10,000,000.00).

The said object of expenditures shall be expended to hire consultants for advice and/or research necessary for adoption and enactment of legislative measures and for other legislative affairs/concerns of the City Council covering the period June 1 to December 31, 2018.

SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on April 23, 2018.


