AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 2, CY 2018, IN THE AMOUNT OF FIFTY-NINE MILLION THREE HUNDRED FORTY-FOUR THOUSAND ONE HUNDRED NINETEEN PESOS AND FORTY-SIX CENTAVOS (PHP. 59,344,119.46)

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Authorization. - Supplemental Budget No. 2, involving an amount of Fifty-Nine Million Three Hundred Forty-Four Thousand One Hundred Nineteen Pesos and Forty-Six Centavos (Php. 59,344,119.46), representing the 30% share of the City of Manila in the proceeds from the incremental collection of Value Added Tax (VAT) for CY 2016, is hereby authorized, to wit:

SEC. 2. Source of Funds. – The funds necessary to execute this Ordinance as specified in Section 1 hereof in the amount of Fifty-Nine Million Three Hundred Forty-Four Thousand One Hundred Nineteen Pesos and Forty-Six Centavos (PhP. 59,344,119.46), sourced from proceeds of incremental collection of Value Added Tax (VAT) for CY 2016; and duly certified by the City Treasurer and City Accountant as available, is hereby appropriated.

SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on July 23, 2018.
