## **ORDINANCE NO. 8558**

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a. OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF GERARDO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Gerardo Tricycle Operators & Drivers Association, Incorporated (G. TODA, INC.), to read as follows:

# "GERARDO TRICYCLE OPERATORS & DRIVERS ASSOCIATION INCORPORATED (G. TODA, INC.)

## Loading and Unloading Areas

1. Loading -

a. Gerardo corner G. Tuazon Streets

2. Unloading - a. Batanes Street

b. Luzon Street

c. Masbate Street d. G. Tuazon Street"

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Gerardo Tricycle Operators and Drivers Association, Incorporated (G. TODA, INC.), to read as follows:

### "ASSOCIATION

R.M.C.

Gerardo Tricycle Operators and Drivers Associations, Incorporated (G. TODA, INC.)

45 Units

#### ROUTE

The authorized route line of operation shall be via Gerardo corner G. Tuazon Streets - Batanes Street - Luzon Street - Masbate Street - G. Tuazon Street and vice-versa."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- SEC. 4. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provision of this Ordinance are hereby repealed, amended or modified accordingly.
- SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval

This Ordinance was finally enacted by the City Council of Manila on March 18, 2019.
