## **ORDINANCE NO. 8570**

AN ORDINANCE FURTHER AMENDING SECTION 3 OF CITY ORDINANCE NO. 8362, AS AMENDED BY ORDINANCE NO. 8457, ENTITLED: "AN ORDINANCE GRANTING BIRTHDAY GIFTS TO ALL SENIOR CITIZENS OF MANILA, AND FOR OTHER PURPOSES"

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 3 of Ordinance No. 8362, as amended by Ordinance No. 8457, is hereby amended to increase the value of the Birthday Gift entitlement of senior citizens of the City of Manila, to read as follows:

- "SEC. 3. BIRTHDAY GIFT. All Senior Citizens or elderly shall be granted a yearly Birthday Gift, in the amount of Eight Hundred Pesos (PhP. 800.00), to be given in cash or in kind or a combination thereof."
- SEC. 2. Appropriation. The City Government shall appropriate funds therefor which shall be used for the above purposes mandated by this Ordinance in the City's Annual Budget, and every year thereafter.
- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- SEC. 4. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provision of this Ordinance are hereby repealed, amended or modified accordingly.
- SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval and after publication in a newspaper of general circulation which appropriation shall be included in the Calendar Year 2020 Executive Budget and thereafter.

This Ordinance was finally enacted by the City Council of Manila on August 15, 2019.
