## ORDINANCE NO. 8578

**AN ORDINANCE** CREATING TEN (10) NURSE I POSITIONS (SG-11) TO FACILITATE THE TRANSFER OF NURSE I EMPLOYEES OF OSPITAL NG MAYNILA MEDICAL CENTER, CURRENTLY OCCUPYING THE NURSE I POSITION UNDER THE CLINICAL NURSING DEVELOPMENT PROGRAM, AND TO INCLUDE THE TEN (10) NURSE I POSITIONS IN THE REGULAR PLANTILLA ITEMS

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1. Declaration of Policy.** – It is hereby declared the policy of the City Government to provide equal opportunity to regular employees and those employees classified under the Lump-Sum Appropriations-CNRPD under the Personal Services, through integration with the Regular Plantilla Items as far as status of employment are concerned, and entitlement to other benefits given to regular employees.


**SEC. 2. Creation of ten (10) Nurse I positions and corresponding Salary Grades.** – The positions of ten (10) Nurse I bearing Salary Grade 11 for Ospital ng Maynila Medical Center are hereby created and the existing Nurse I positions under the Clinical Nursing Development Program (CNRDP), are hereby converted into Regular Plantilla Items (RPI) for legitimacy of their current status of employment.

**SEC. 3. Appropriation.** – The amount necessary to implement this Ordinance is hereby appropriated out of any fund not otherwise appropriated as existing in the City Treasury. Thereafter, subsequent appropriations for the positions created shall be integrated in the Annual Budget of the City of Manila.

**SEC. 4. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 24, 2019.


