



ORDINANCE NO. 8580

AN ORDINANCE AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 1, FISCAL YEAR 2019, IN THE AMOUNT OF SEVENTY-TWO MILLION NINE HUNDRED SEVENTY-FIVE THOUSAND EIGHT HUNDRED FIFTY-FIVE PESOS AND THIRTY CENTAVOS (PHP. 72,975,855.30), FOR THE DEPARTMENT OF ENGINEERING AND PUBLIC WORKS TO BE ALLOTTED FOR THE VERTICAL SOCIALIZED HOUSING PROJECT

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Authorization. - Supplemental Budget No. 1, Fiscal Year 2019, involving an amount of Seventy-Two Million Nine Hundred Seventy-Five Centavos Thirty Fifty-Five Pesos and Eight Hundred Thousand (PhP. 72,975,855.30), is hereby authorized, to wit:

SEC. 2. Source of Funds. - The funds necessary to execute this Ordinance as specified in the preceding Section 1 hereof in the amount of Seventy-Two Million Nine Hundred Seventy-Five Thousand Eight Hundred Fifty-Five Pesos and Thirty Centavos (PhP. 72,975,855.30), is hereby appropriated from funds actually available as duly certified by the City Treasurer.

SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 28, 2019.
