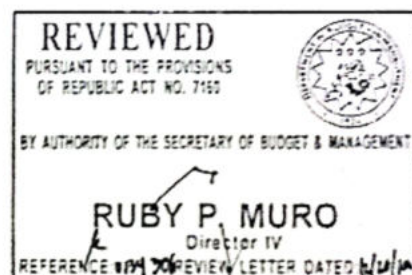

**ORDINANCE NO. 8582**

**AN ORDINANCE** APPROPRIATING THE AMOUNT OF FIVE HUNDRED FIFTY EIGHT MILLION FIVE HUNDRED SEVENTY THOUSAND PESOS (PHP. 558,570,000.00) AS GENERAL FUND SUPPLEMENTAL BUDGET NO. 2, TO BE MADE AVAILABLE AS ADDITIONAL APPROPRIATIONS OF THE CITY OF MANILA FOR CALENDAR YEAR 2019

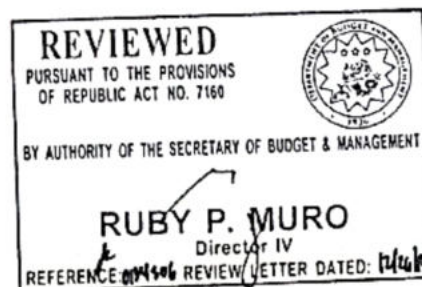
Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** There is hereby appropriated from the General Fund, sourced from Tax Revenue and Reversion of Appropriations, and which are not otherwise appropriated, the sum of Five Hundred Fifty-Eight Million Five Hundred Seventy Thousand Pesos (PhP. 558,570,000.00), as General Fund Supplemental Budget No. 2, and which budget documents, marked as Annex "A", for Statement of Funding Sources (LBP form No. 8), and Annex "B" for Statement of Supplemental Appropriation (LBP form No. 9), are attached and made integral parts hereof, to be made available as additional appropriations of the City Government of Manila for Calendar Year 2019.

The herein appropriation of funds represents the authorized supplemental budgetary support for the payment of Productivity Incentive Allowance (Productivity Enhancement Incentive under DBM Budget Circular No. 2017-4 dated December 4, 2017) of city government personnel, welfare goods, allowance to National Agencies-Regional Trial Court and Construction of Sewerage Treatment Plant at Manila Zoo and which are incorporated in the following items of expenditures.






