ORDINANCE NO. 8583

AN ORDINANCE REALIGNING THE AMOUNT OF EIGHTY-NINE MILLION SIX HUNDRED FIFTY THOUSAND PESOS (PHP. 89,650,000.00), APPROPRIATED UNDER THE CAPITAL OUTLAY CY 2019 OF THE DEPARTMENT OF ENGINEERING AND PUBLIC WORKS, AUTHORIZED THROUGH ORDINANCE NO. 8555, OTHERWISE KNOWN AS THE EXECUTIVE BUDGET FOR CY 2019, SHALL BE USED INSTEAD FOR NEW PROJECTS UNDER THE PARKS, PLAZAS AND MONUMENTS ACCOUNT OF THE SAME AGENCY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. The program of expenditures enumerated below allocated under the Capital Outlay CY 2019 of the Department of Engineering and Public Works amounting to Eighty-Nine Million Six Hundred Fifty Thousand Pesos (PhP. 89,650,000.00), authorized through Ordinance No. 8555, otherwise known as the Executive Budget for CY 2019, shall now be realigned to be expended for new projects:
