ORDINANCE NO. 8584

AN ORDINANCE ESTABLISHING A SUSTAINED MILK AND NUTRIBUN FEEDING PROGRAM FOR ALL PRESCHOOL STUDENTS ENROLLED IN PUBLIC KINDERGARTEN AND ALL GRADE 1 STUDENTS ENROLLED IN PUBLIC SCHOOLS IN THE CITY OF MANILA, AMENDING FOR THE PURPOSE ORDINANCE NO. 8380, AND FOR OTHER PURPOSES

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. It is hereby declared the policy of the City Government of Manila, consistent with Section 15, Article II, of the Constitution, to effectively address the nutritional needs of students in the primary academic level in order to aid in their full learning potential and thus supplement their efforts to reach their higher academic levels.

SEC. 2. A sustained Milk and Nutribun Feeding Program for one hundred twenty (120) school days is hereby established for all preschool students enrolled in kindergarten and all Grade 1 students enrolled in public schools in the City of Manila, in which milk and nutribun meals shall be served individually on such students, both for the morning and afternoon batches.

If there is a need to continue the Milk and Nutribun Feeding Program in cases where there still malnutrition in kindergarten and Grade 1 students in the City of Manila, said program shall be extended under the provisions of this Ordinance.

- SEC. 3. Within thirty (30) days from the approval of this Ordinance, the Manila Health Department (MHD) and the Division of City Schools of Manila under the Department of Education (DepEd) shall formulate rules and guidelines implementing the provisions hereof, which shall include, but not limited to, the following:
 - The mandatory examination of students covered by program based on the age-to-weight ratio and the documentation thereof;
 - The integration of the nutritional formula prepared by the Manila Health Department for the nutribun mass-production;
 - The outsourcing of qualified bakeries for the mass-production of nutribun according to the total number of students in all public preschool and primary level schools;
 - d. The procurement of safe local milk or milk products from qualified suppliers;
 - The procurement of basic hygiene items, such as disposable cups for milk and proper packing for individual nutribun items for individual serving per student;
 - f. The creation of a monitoring group for the random inspection of schools covered by this Ordinance for the purpose of ensuring compliance hereof; and
 - g. The periodic inspection of individual students to determine their health status based on their age-to-weight ratio.
- SEC. 4. The amount of One Hundred Seventy-Three Million Pesos (PhP. 173,000,000.00) or so much thereof as they may be necessary is hereby appropriated out of any available and existing funds in the City Treasury of Manila.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 28, 2019.
