**ORDINANCE NO. 8596**

**AN ORDINANCE** CREATING THE POSITION OF DRIVER IV WITH SALARY GRADE 10, THROUGH THE ABOLITION OF THE POSITION OF ENGINEER II WITH SALARY GRADE 16, TO LEAD THE MOTORPOOL UNIT OF OSPITAL NG MAYNILA MEDICAL CENTER

PREAMBLE

WHEREAS, the Engineer II position of Ospital ng Maynila Medical Center has been vacant for the past several years, and the hospital management has deemed it economical to abolish the said position to give for the creation of Driver IV to lead its Motorpool Unit and, at the same time, maximize its own plantilla to give chance to deserving employee qualified for the position: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1. CREATION OF DRIVER IV.** - The existing position of Engineer II bearing Salary Grade 16 (Item No. 129), in the Old Personnel Schedule FY 2020 of the Ospital ng Maynila Medical Center, is hereby abolished to be replaced by the position of Driver IV bearing Salary Grade 10 (Item No. 132), in the New Personnel Schedule FY 2020.


**SEC. 2. EFFECTIVITY CLAUSE.** - This Ordinance, upon approval, shall take effect after ten (10) days from publication in a newspaper of general circulation pursuant to Section 59 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.
