**ORDINANCE NO. 8610**

**AN ORDINANCE** FURTHERMORE AMENDING SECTION 7 OF ORDINANCE NO. 3358, AS AMENDED BY ORDINANCE NOS. 3363 AND 3532, BY EXEMPTING CERTAIN AREAS AND/OR ESTABLISHMENTS CATERING TO TOURISTS ALONG ROXAS BOULEVARD TO TAFT AVENUE, T.M. KALAW AND ADRIATICO STREETS TO QUIRINO AVENUE TO BOOST TOURISM IN THE CITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:


**SECTION 1.** Section 7 of Ordinance 3358, as amended by Ordinance Nos. 3363 and 3532, is hereby furthermore amended to read as follows:

**"SEC. 7. – Licenses for sale of liquor in certain places prohibited. – No license shall be granted for the sale of intoxicating liquors in public markets, kiosks, booths, or stands situated in the public streets or plazas or to street vendors or peddlers, or in any case, to an establishment located within a radius of 200 meters from any institutions of learning, except establishments duly authorized to cater to tourists along Roxas Boulevard to Taft Avenue, T.M. Kalaw and Adriatico Streets to Quirino Avenue to boost tourism in the City which are hereby expressly exempted from the prohibition."**


**SEC. 2. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 23, 2020.
