## **ORDINANCE NO. 8626**

AN ORDINANCE AMENDING ORDINANCE NO. 8620 TO INCLUDE DOCTORS, NURSES AND ALLIED PROFESSIONALS RENDERING SERVICE AT THE MANILA HEALTH DEPARTMENT AND THE SIX (6) HOSPITALS OF THE CITY OF MANILA IN THE GRANT OF FINANCIAL ASSISTANCE BY THE CITY GOVERNMENT IN THE AMOUNT OF THREE THOUSAND PESOS (PHP. 3,000.00) UNDER OTHER PROFESSIONAL SERVICES AND CONSULTANCY SERVICES AND FOR OTHER PURPOSES

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. FINANCIAL ASSISTANCE. In addition to the Regular Employees and Job Order Workers of the City of Manila, Doctors, Nurses and Allied Professionals who are rendering service at the Manila Health Department and the six (6) Hospitals of the City of Manila shall also be granted the amount of Three Thousand Pesos (PhP. 3,000.00) as Financial Assistance of the City Government under other professional services and consultancy services.

SEC. 2. FUNDING. The amount needed to fund said financial assistance shall be sourced from available appropriations under Ordinance No. 8620 or An Ordinance Authorizing the Supplemental Budget No. 1 for Fiscal Year 2020, Appropriating the Amount of Sixty Million Pesos (Php. 60,000,000.00) to be utilized as Financial Assistance for All Employees and Job Order Workers of the City Government of Manila.

SEC. 3. EFFECTIVITY CLAUSE. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on April 13, 2020.
