ORDINANCE NO. 8629

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 03, SERIES OF 2020, TO APPROPRIATE THE BAYANIHAN GRANT TO THE CITY OF MANILA IN THE AMOUNT OF TWO HUNDRED NINETY-TWO MILLION SIX HUNDRED THOUSAND FOUR HUNDRED EIGHTY-SEVEN PESOS (PHP. 292,600,487.00) AND FOR OTHER PURPOSES

PREAMBLE

WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Circular No. 125, dated April 7, 2020, to all local chief executives, members of the local sanggunian, local budget officers, local treasurers, local planning and development coordinators, local accountants and all other concerned to serve as guidelines on the release and utilization of the Bayanihan Grant to Cities and Municipalities;

WHEREAS, the said Circular was in line with Republic Act (RA) No. 11469 (*the Bayanihan to Heal as One Act*) which granted the President the power to adopt various temporary emergency measure to respond to crisis brought about by the Coronavirus Disease 2019 (COVID-19) pandemic;

WHEREAS, in the same law, the President is empowered to “ensure that all Local Government Units (LGUs) are acting within the letter and spirit of all the rules, regulations and directives issued by the National Government pursuant to the said law, and are implementing standards of Community Quarantine consistent with what the National Government has laid down for the subject area, while allowing the LGUs to continue exercising their autonomy on matters undefined by the National Government or are within the parameters it has set, and are fully cooperating towards a unified, cohesive and orderly implementation of the national policy to address COVID-19” (**Section 4 (g) of RA No. 11469**);

WHEREAS, the utilization of this funding shall be subject to the usual local budgeting process pursuant to the pertinent provisions of the Local Government Code of 1991 (RA No. 7160);

WHEREAS, earlier today, the local legislative body approved Resolution No. 3, Series of 2020, adopted on April 16, 2020 by the Executive Committee of the City Development Council, entitled: “A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM OR ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2020 IN RELATION TO THE ALLOCATION OF TWO HUNDRED NINETY-TWO MILLION, SIX HUNDRED THOUSAND, FOUR HUNDRED EIGHTY-SEVEN PESOS (PHP. 292,600,487.00) FROM THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES FOR THE CITY OF MANILA”;

WHEREAS, the passage of this Supplemental Budget is in accordance with **Section 321 of Republic Act No. 7160** which provides that “all budgetary proposal shall be included and considered in the budgetary preparation process. After the local chief executive concerned shall have submitted the Executive Budget to the sanggunian, no ordinance providing for a supplemental budget be enacted, except when supported by funds actually available as certified by the local treasurer or by new revenue sources.”
NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Appropriation of Funds. - The Supplemental Budget, appropriating the BAYANIHAN GRANT TO THE CITY OF MANILA, in the amount of Two Hundred Ninety-Two Million Six Hundred Thousand Four Hundred Eighty-Seven Pesos (PhP. 292,600,487.00), is hereby approved.

SEC. 2. Sources of Funds. - The source of Funds for the Supplemental Budget in the total amount of Two Hundred Ninety-Two Million Six Hundred Thousand Four Hundred Eighty-Seven Pesos (PhP. 292,600,487.00), shall be derived from the Bayanihan Grant to the City of Manila under the Republic Act (RA) No. 11469.

SEC. 3. Use of Fund. – The amount of Two Hundred Ninety-Two Million Six Hundred Thousand Four Hundred Eighty-Seven Pesos (PhP. 292,600,487.00), is hereby appropriated for the programs, activities and projects of the City Government of Manila, as follows:



SEC. 4. Accountability. – A Special Account in the General Fund shall be created covering the Bayanihan Grant to the City of Manila for easy monitoring/tracking of the utilization of the fund in accordance with Section 313 of the Local Government Code. Disbursement of funds shall be subject to existing laws, rules and regulations.

SEC. 5. Effectivity Clause. – This Ordinance shall take immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on April 17, 2020.


