**ORDINANCE NO. 8630**

**AN ORDINANCE** AMENDING ORDINANCE NO. 8625 BY HEREIN SUPPLEMENTAL BUDGET NO. 04, SERIES OF 2020, AUGMENTING THE AMOUNT ALLOCATED FOR THE CITY AMELIORATION CRISIS ASSISTANCE FUND (CACAF) IN THE AMOUNT OF TWENTY MILLION PESOS (PHP. 20,000,000.00)

## PREAMBLE

WHEREAS, the Local Government Code states that "a supplemental budget may also be enacted in times of public calamity by way of budgetary realignment to set aside appropriations for the purchase of supplies and materials or the payment of services which are exceptionally urgent or absolutely indispensable to prevent imminent danger to, or loss of, life or property, in the jurisdiction of the local government unit or in other areas declared by the President in a state of calamity. Such ordinances shall clearly indicate the sources of funds available for appropriations, as certified under oath by the local treasurer and local accountant and attested by the local chief executive, and the various items of appropriations affected and the reasons for the change." [Section 321 of Republic Act No. 7160];

WHEREAS, on April 5<sup>th</sup>, 2020, the City Council of Manila passed Ordinance No. 8625 entitled: "An Ordinance authorizing the Supplemental Budget No. 02, Series of 2020, through Budgetary Realignment, involving an amount of Five Hundred Ninety-One Million Five Hundred Thousand Pesos (PhP. 591,000,000.00), for the City Amelioration Crisis Assistance Fund" in accordance with Section 321 of R.A. No. 7160;

WHEREAS, the intention of the said Ordinance is to provide immediate assistance to all the families residing, whether temporary or permanently, in the City of Manila while the entire City is under the Enhance Community Quarantine (ECQ), as ordered by the President;

WHEREAS, the City Amelioration Crisis Assistance Fund (CACAF) was provided by the City of Manila because the supply of basic commodities has been scarce due to its high demand and production challenges causing difficulties in the immediate distribution of the relief goods to the entire population of the city;

WHEREAS, after the implementation of the CACAF in the eight hundred ninety-six (896) Barangays, a number of barangays appealed for additional funding to accommodate those families who have not benefited from the said fund;

WHEREAS, earlier today, the local legislative body approved Resolution No. 4, Series of 2020, adopted on April 16, 2020 by the Executive Committee of the City Development Council, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM OR ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2020 IN RELATION TO THE ADDITIONAL TWENTY MILLION PESOS (PHP. 20,000,000.00) CITY AMELIORATION CRISIS ASSISTANCE FUND AS FINANCIAL ASSISTANCE FOR RESIDENTS OF THE CITY OF MANILA": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1. APPROPRIATIONS.** – Ordinance No. 8625 is hereby amended by herein Supplemental Budget augmenting the amount of the City Amelioration Crisis Assistance Fund (CACAF) by Twenty Million Pesos (PhP. 20,000,000.00).

**SEC. 2. SOURCES OF FUND.** – The source of funds for the Supplemental Budget in the total amount of Twenty Million Pesos (PhP. 20,000,000.00), shall be derived from the Office of the Mayor [Maintenance and Other Operating Expenses (MOOE) – Donation Account].

**SEC. 3. USE OF FUNDS.** – The amount of Twenty Million Pesos (PhP. 20,000,000.00) is hereby appropriated for the Supplemental Budget of the City Government of Manila as City Amelioration Crisis Assistance Fund under the Maintenance and Other Operating Expenses (MOOE) – Donation Account of the Manila Department of Social Welfare.


**SEC. 4. BENEFICIARIES.** – The amount of One Thousand Pesos (PhP. 1,000.00) per beneficiary shall be given to the barangay-identified beneficiaries, who were not able to avail of the funding from Ordinance No. 8625, as financial assistance to be distributed to various Barangays in the City of Manila to cushion the economic effect of COVID-19 crisis and to enable the people of Manila to purchase much needed food and supplies for their survival.

**SEC. 5. ACCOUNTABILITY.** The amount appropriated in this Ordinance shall be coursed through the barangays concerned, who shall be in-charge of the proper liquidation of the said fund, subject to existing laws, rules and regulations.


**SEC. 6. EFFECTIVITY CLAUSE.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on April 17, 2020.


