ORDINANCE NO. 8641

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 07, SERIES OF 2020, APPROPRIATING THE AMOUNT OF FIFTEEN MILLION THREE HUNDRED EIGHT THOUSAND SIX HUNDRED TWENTY PESOS (PHP. 15,308,620.00) FROM THE SPECIAL ACCOUNT IN THE GENERAL FUND TO THE MANILA HEALTH DEPARTMENT — OTHER MAINTENANCE AND OPERATING EXPENSES AND DEPARTMENT OF ENGINEERING AND PUBLIC WORKS—CAPITAL OUTLAY

PREA MBLE

WHEREAS, the number of COVID-19 cases within the Philippines continues to rise with more than 700 confirmed patients the City of Manila as of 6 May 2020;

WHEREAS, together with the imposition of the Enchanced Community Quarantine, an increase in the conduct of COVID-19 testing within the City of Manila must be immediately effected;

WHEREAS, the utilization of this funding shall be subject to the usual local budgeting process pursuant to the pertinent provisions of the Local Government Code of 1991 (RA No. 7160);

WHEREAS, earlier today, the local egislative body approved Resolution No. 7, Series of 2020, adopted on May 7, 2020 by the Executive Committee of the City Development Council, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM OR ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2020 IN RELATION TO THE AMOUNT OF FIFTEEN MILLION THREE HUNDRED EIGHT THOUSAND SIX HUNDRED TWENTY PESOS (PHP. 15,308,620.00) COVERING THE BAYANIHAN GRANT AND APPROPRIATING IT FOR THE FOLLOWING (A) COVID-19 TESTING EXPENSES OF THE CITY OF MANILA UNDER THE MANILA HEALTH DEPARTMENT – OTHER MAINTENANCE AND OPERATING EXPENSES IN THE A TOUNT OF TEN MILLION PESOS (PHP. 10,000,000.00); AND (B) CONSTRUCTION REPAIR OF QUARANTINE FACILITIES OF THE CITY OF MANILA UNDER THE DEPARTMENT OF ENGINEERING AND PUBLIC WORKS-CAPITAL OUTLAY IN THE AMOUNT OF FIVE MILLION THREE HUNDRED EIGHT THOUSAND SIX HUNDRED TWENT Y PESOS (PHP. 5,308,620.00)";

WHEREAS, this Supplemental Budget is in accordance with Section 321 of Republic Act No. 7160 which provides that all budgetary proposal shall be included and considered in the budgetary preparation process. After the local chief executive concerned shall have submitted the Executive Budget to the sanggunian, no ordinance providing for a supplemental budget be enacted, except when supported by funds actually available as certified by the local treasurer or by new revenue sources.": NOW, THEREFORE,

Be it ordained by the City Council of Manila, a session assembled, THAT:

SECTION 1. The Supplemental Budge of the City Government of Manila for Fiscal Year 2020 in the amount of Fifteen Million Three Hundred Eight Thousand Six Hundred Twenty Pesos (PhP. 15,308,620. D), from the Special Account in the General Fund is hereby approved.

SEC. 2. Sources of Funds. - The source of funds for the Supplemental Budget in the total amount of Fifteen Million Three Hundred Eight Thousand Six Hundred Twenty Pesos (PhP. 15,308,620.00) shall be derived from the Special Account in the General Fund.

SEC. 3. Use of Funds. - The amount of Fifteen Million Three Hundred Eight Thousand Six Hundred Twenty Pesos PHP 15,308,620.00), is hereby appropriated and broken down as follows:
