AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED MILLION PESOS (PHP. 100,000,000.00) OR SO MUCH THEREOF AS MAYBE NECESSARY FOR THE PAYMENT OF INTERNAL REVENUE TAXES, FEES AND OTHER CHARGES THERETO IN RELATION TO THE SALE OF PROPERTY OWNED BY THE CITY OF MANILA LOCATED AT ESCOLTA, MANILA, CONSISTING OF TEN (10) PARCELS OF LAND AND COVERED BY TRANSFER CERTIFICATE OF TITLE NOS. 46911 TO 46920, IN THE REGISTRY OF DEEDS FOR THE CITY OF MANILA

E a dear ed by the City Council of Manila, in session assembled, THAT:

SECTION 1. – The amount of One Hundred Million Pesos (PhP. 100,000,000.00) or so much thereof, as maybe necessary, is hereby appropriated for the payment of recent revenue taxes, fees and other charges in relation to the sale of property owned by the City Government of Manila located at Escolta, Manila consisting of ten (10) parcels of land and covered by Transfer Certificate of Title Nos. 46911 to 46920, in the Registry of Deeds for the City of Manila, subject to applicable laws and auditing rules and procedures.

- SEC. 2. All ordinances, resolutions and executive orders which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 3. This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on June 15, 2020.
