#### ORDINANCE NO. 8650

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF LORETO SAMPALOC TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (LORTODA), INC., AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Loreto Sampaloc Tricycle Operators and Drivers Association (LORTODA), Inc., to read as follows:

## "LORETO SAMPALOC TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (L'ORTODA), INC.

#### Loading and Unloading Areas

a Legarda, Loreto, Rotonda and Vice Versa"

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Loreto Sampaloc, Tricycle Operators and Drivers Association, Inc., to read as follows:

#### "ASSOCIATION

<u>R.M.C.</u>

Loreto Sampaloc Tricycle Operators and Drivers Association (LORTODA), Inc

35 Units

#### ROUTE

The authorized route lines of operation shall be via Legarda corner A.H. Lacson to J.P. Laurel and back, to A.H. Lacson up to G. Tuazon right to Loreto right to Magsaysay St., Sta. Mesa and vice versa "

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- SEC. 4. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsisten with the provisions of this Ordinance are hereby repealed or modified accordingly.
  - SEC. 5. Effectivity Clause. This Offinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on June 25, 2020.
