## **ORDINANCE NO. 8658**

AN ORDINANCE AMENDING ORDINANCE NOS. 8647 AND 8616 BY IMPOSING THE CURFEW IN THE CITY OF MANILA ACCORDING TO THE QUARANTINE CLASSIFICATIONS AND FOR OTHER PURPOSES

## PREAMBLE

WHEREAS, on March 12, 2020, the Inter-Agency Task Force for the Management of Emerging Infectious Disease, with the approval of President Rodrigo Roa Duterte, raised the Code Alert Level to Code Red Sublevel Two and the imposition of stringent Social Distancing Measures in the National Capital Region (NCR) for thirty (30) days, effective March 15, 2020;

WHEREAS, the Metro Manila Council, during the meeting held on March 14, 2020, agreed to pass a resolution for all Local Government Unit in the NCR to pass an Ordinance implementing a curfew for all residents and persons in the jurisdiction of the LGUs between 8:00 pm to 5:00 am to further implement the SOCIAL DISTANCING measures to CONTAIN and DELAY the further spread of the Covid-19 in the Metropolitan Area, and to the whole country;

WHEREAS, this measure is necessary during the duration of the imposition of the Community Quarantine ordered by the President: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Imposition of Curfew Hours; Covered Persons. – <u>There is hereby imposed curfew hours for all persons in the City of Manila, depending on the quarantine classification of the National Capital Region, to wit:</u>

Enhanced Community Quarantine - between Eight O'clock in the evening (8:00 pm) to Five O'clock in the morning (5:00 am).

Modified Enhanced Community Quarantine - between Eight O'clock in the evening (8:00 pm) to Five O'clock in the morning (5:00 am).

General Community Quarantine – between Ten O'clock in the evening (10:00 pm) to Five O'clock in the morning (5:00 am).

**SEC. 2. Exceptions.** – During curfew hours, no persons shall be allowed in the streets, commercial establishments, recreation centers, malls or any other areas outside the immediate vicinity of their residence, except in cases of emergency or for the purpose of purchase of food and essential basic necessities and prime commodities and work related travels.

The movement of cargoes within the City of Manila shall be unhampered.

- **SEC. 3. Role of the Barangays.** The Punong Barangay, members of the Barangay Council and the duly designated Barangay Tanods are hereby authorized to implement the provision of this Ordinance
- **SEC. 4. Guidelines in Apprehension.** Offenders of this Ordinance shall be apprehended in accordance with the guidelines to implement the provisions of this Ordinance:
  - 1. The apprehending official or officer shall, without necessary delay, notify the family member/s of the offender and release the offender in recognizance to said family member/s with the understanding that the offender shall be submitted to the Punong Barangay for the corresponding penalty under Section 5 of this Ordinance;

facility of the barangay where the apprehension was made for not more than twenty-four (24) hours, and thereafter if the release of the offender to his/her family member cannot be reasonably accomplished, the Punong Barangay concerned shall turn over the offender to the Manila Department of Social Welfare Office concerned for proper disposition;

- 3. For an offender who is homeless, abandoned, neglected, or have no known family member, the apprehending official or officer shall refer the offender to the custody of the Manila Department of Social Welfare concerned within twenty-four (24) hours of apprehension;
- 4. Those who were apprehended for the violation(s) under this Ordinance and detained for more than two (2) days may be released by the prosecutor on recognizance upon signing of an undertaking that on repetition of the same offense, the full force of the Ordinance will be applied;

SEC. 3. EFFECTIVITY. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on August 5, 2020.
