ORDINANCE NO. 8661

AN ORDINANCE APPROVING THE RE-ALLOCATION OF THE SALARY GRADE OF RADIOLOGIC TECHNOLOGIST POSITIONS IN THE VARIOUS CITY GOVERNMENT HOSPITALS AND IN THE MANILA HEALTH DEPARTMENT, PURSUANT TO DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) CIRCULAR NO. 2018-2

PREAMBLE

WHEREAS, the field of Radiology has evolved to become a vital component of health care by being a key diagnostic tool for diseases and as an instrument for monitoring treatments. Radiologic Technologists, who have become key members of the health care team, have to keep pace with technological developments and be knowledgeable in all modalities of radiologic examination and monitoring while confronting the challenges of the current COVID-19 global pandemic;

WHEREAS, the Department of Budget and Management (DBM) had issued Budget Circular No. 2018-02 which prescribes the rules and regulations in the adjustment of the Salary Grades of the Radiologic Technologist II to Radiologic Technologist V classes of positions for all national government agencies, government-owned or —controlled corporations and local government units effective last April 01, 2018;

WHEREAS, the funds from the Personnel Schedule of the requesting hospitals and department necessary to implement the salary rate adjustment of the re-allocated Radiologic Technologist positions were already included and made integral of the approved 2020 City Executive Budget of Manila;

WHEREAS, the City Council of Manila passed a similar Ordinance No. 8587 on November 07, 2019 providing for the re-allocation of the salary grade of Radiologic Technologist of the Ospital ng Maynila Medical Center: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Declaration of Policy. – It is hereby declared the policy of the City Government of Manila to comply with the prescribed rules and regulations contained under the DBM Circular No. 2018-2 regarding the re-allocation of Radiologic Technologist positions.

SEC. 2. Re-allocation of Radiologic Technologist Classes of Positions. – The salary grade of the following classes of Radiologic Technologist positions are hereby re-allocated in all City Government Hospitals and in the Manila Health Department, as follows:

The Radiologic Technologist I position shall continue to be allocated under Salary Grade 11, based on Section 4 of the said Circular.

- **SEC. 3. Appropriation.** The amount necessary to implement this Ordinance shall be taken from existing and available funds appropriated for such purpose under the approved City Executive Budget for 2020. Thereafter, all subsequent appropriations shall be integrated in the annual budget of the City of Manila.
- SEC. 4. Effectivity clause. Upon approval of this Ordinance, the concerned hospitals and department can apply to retroactively implement the salary rate adjustment effective at the beginning of the Fiscal Year 2020 after securing a Certification of Availability of Funds from the Office of the City Accountant and City Treasurer's Office.

This Ordinance was finally enacted by the City Council of Manila on August 20, 2020.
