AN ORDINANCE REALIGNING THE AMOUNT OF FIVE MILLION ONE HUNDRED THOUSAND PESOS (PHP. 5,100,000.00), FROM SAVINGS FROM VARIOUS ACCOUNTS UNDER THE OFFICE OF THE MAYOR MAINTENANCE AND OTHER OPERATING EXPENSES, AUTHORIZED THROUGH ORDINANCE NO. 8585, OTHERWISE KNOWN AS THE EXECUTIVE BUDGET OF FY 2020, TO AUGMENT THE MAINTENANCE AND OTHER OPERATING EXPENSES – CONSULTANCY SERVICES OF THE SAME OFFICE TO COVER THE PAYMENT OF SALARIES OF FIFTY-TWO (52) CONSULTANTS OF THE OFFICE OF THE MAYOR UNTIL DECEMBER 31, 2020

Be it ordained by the City Council of Manila, in session assembled, **THAT**:

SECTION 1. The realignment of the amount of Five Million One Hundred Thousand Pesos (PhP. 5,100,000.00), from savings from various accounts under the Office of the Mayor Maintenance and Other Operating Expenses, authorized through Ordinance No. 8585, otherwise known as the Executive Budget of FY 2020, to augment the Maintenance and Other Operating Expenses – Consultancy Services of the same office to cover the payment of salaries of fifty-two (52) Consultants of the Office of the Mayor until December 31, 2020, is hereby authorized as follows:


