ORDINANCE NO. 8687

AN ORDINANCE APPROPRIATING ONE HUNDRED THIRTY-THREE MILLION EIGHT HUNDRED FIFTY-SEVEN THOUSAND SIX HUNDRED SEVENTY-SIX PESOS AND SIXTY-EIGHT CENTAVOS (PHP. 133,857,676.68) AS SUPPLEMENTAL BUDGET NO. 17 FOR FISCAL YEAR 2020 TO COVER THE WELFARE GOODS EXPENSES FOR THE "PAMASKONG HANDOG PARA SA SENIOR CITIZENS NG MAYNILA", AND FOR THE CONSTRUCTION OF A MOLECULAR LABORATORY AT THE OSPITAL NG MAYNILA MEDICAL CENTER AND OTHER PURPOSES

PREAMBLE

WHEREAS, on 8 March 2020 Presidential Proclamation No. 922, S. 2020, was issued declaring a State of Public Health Emergency throughout the Philippines due to the Coronavirus Disease 2019 (COVID-19) and the Code Alert System for COVID-19 was raised to Code Red Sublevel Two (2) in accordance with the recommendation of the Department of Health (DOH) and the Inter-Agency Task Force for the Management of Emerging Infectious Diseases. In view of the continuing rise of confirmed cases of COVID-19, the serious threat to the health, safety, security, and lives of our countrymen, the long-term adverse effects on their means of livelihood, and the severe disruption of economic activities, a state of national emergency is hereby declared over the entire country;

WHEREAS, said Presidential Proclamations enjoined all government agencies and Local Government Units (LGUs) to render full assistance to and cooperation with each other and mobilize the necessary resources to undertake critical, urgent, and appropriate disaster response aid and measures in a timely manner to curtail and eliminate the threat of COVID-19;

WHEREAS, further, no less than the 1987 Constitution under Article XIII, Section 11 thereof, specifically provides that the state shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost and prioritizing, among others, the elderly;

WHEREAS, consistent with the Constitution, the City Government of Manila has continuously produced programs and projects for the benefit and welfare of the elderly;

WHEREAS, the Local Government Code of 1991, states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants" (Section 16 of Republic Act No. 7160);

WHEREAS, the same Code provides that all budgetary proposals shall be included and considered in the budget preparation process. After the local chief executive concerned shall have submitted the executive budget to the Sanggunian, no Ordinance providing for a supplemental budget shall be enacted, except when supported by funds actually available as certified by the local treasurer or by new revenue sources. A supplemental budget may also be enacted in times of public calamity by way of budgetary realignment to set aside appropriations for the purchase of supplies and materials or the payment of services which are exceptionally urgent or absolutely indispensable to prevent imminent danger to, or loss of, life or property, in the jurisdiction of the local government unit or in other areas declared by the President in a state of calamity. Such ordinance shall clearly indicate the sources of funds available for appropriations, as certified under oath by the local treasurer and local accountant and attested by the local chief executive, and the various items of appropriations affected and the reasons for the change (Section 321 par. 1 of Republic Act No. 7160);

WHEREAS, the Code further provides that funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the Presiding Officer of the Sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations (Section 336 of Republic Act No. 7160);

WHEREAS, earlier today, the local legislative body approved Resolution No. 18, Series of 2020, adopted by the Executive Committee of the City Development Council on October 5, 2020, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM OR ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2020 TO COVER THE WELFARE GOODS EXPENSES INTENDED FOR THE SENIOR CITIZENS OF MANILA, AND FOR THE CONSTRUCTION OF A MOLECULAR LABORATORY IN THE TOTAL AMOUNTS OF ONE HUNDRED NINETEEN MILLION FIVE HUNDRED NINETY THOUSAND PESOS (PHP. 119,590,000.00) AND FOURTEEN MILLION TWO HUNDRED SIXTY SEVEN THOUSAND SIX HUNDRED SEVENTY SIX PESOS AND SIXTY EIGHT CENTAVOS (PHP. 14,267,676.68) RESPECTIVELY": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Appropriations. - The Supplemental Budget of the City Government of Manila for Fiscal Year 2020 in the amount of One Hundred Thirty-Three Million Eight Hundred Fifty-Seven Thousand Six Hundred Seventy-Six Pesos and Sixty-Eight Centavos (PhP. 133,857,676.68) is hereby approved.

- SEC. 2. Source of Funds. The source of funds for the Supplemental Budget in the total amount of One Hundred Thirty-Three Million Eight Hundred Fifty-Seven Thousand Six Hundred Seventy Six Pesos and Sixty-Eight Centavos (PhP. 133,857,676.68) shall be derived from the following sources from savings hereby reverted to the general fund:
 - a. Office of the Mayor: Maintenance and Other Operating Expenses Other Maintenance and Operating Expenses amounting to Sixty Nine Million Five Hundred Ninety Thousand Pesos (PhP. 69,590,000.00).
 - b. Urban Settlements Office: Capital Outlay Other Infrastructure Assets amounting to Fifty Million Pesos (PhP. 50,000,000.00).
 - c. Ospital ng Maynila Medical Center: Capital Outlay Medical Equipment amounting to Fourteen Million Two Hundred Sixty-Seven Thousand Six Hundred Seventy-Six Pesos and Sixty-Eight Centavos (PhP. 14,267,676.68).

TOTAL: One Hundred Thirty-Three Million Eight Hundred Fifty Seven Thousand Six Hundred Seventy Six Pesos and Sixty Eight Centavos (PhP. 133,857,676.68).

- SEC. 3. Use of Funds. The amount of One Hundred Thirty-Three Million Eight Hundred Fifty-Seven Thousand Six Hundred Seventy-Six Pesos and Sixty-Eight Centavos (PhP. 133,857,676.68) is hereby appropriated with the following appropriations:
 - Office of the Mayor: Maintenance and Other Operating Expenses -Welfare Goods Expenses for the "PAMASKONG HANDOG PARA SA SENIOR CITIZENS NG MAYNILA" in the total amount of One Hundred Nineteen Million Five Hundred Ninety Thousand Pesos (PhP. 119,590,000.00)



- 2 Ospital ng Maynila Medical Center: Capital Outlay Hospitals and Health Centers for the construction of a Molecular Laboratory at the Ospital ng Maynila Medical Center in the amount of Fourteen Million Two Hundred Sixty-Seven Thousand Six Hundred Seventy-Six Pesos and Sixty-Eight Centavos (PhP. 14,267,676.68)
- SEC. 4. Effectivity Clause. This Ordinance shall take effect immediately upon its approval

This Ordinance was finally enacted by the City Council of Manila on October 8, 2020.
