AN ORDINANCE AMENDING CERTAIN PROVISIONS OF ORDINANCE NO. 8619, ENTITLED: "AN ORDINANCE INSTITUTIONALIZING THE CITY IDENTIFICATION SYSTEM TO ALL RESIDENTS IN THE CITY OF MANILA AND BE KNOWN AS MANILA RESIDENT IDENTIFICATION SYSTEM (MRIS), AND FOR OTHER PURPOSES"

PREAMBLE

WHEREAS, City Ordinance No. 8619, entitled: "AN ORDINANCE INSTITUTIONALIZING THE CITY IDENTIFICATION SYSTEM TO ALL RESIDENTS IN THE CITY OF MANILA AND BE KNOWN AS MANILA RESIDENT IDENTIFICATION SYSTEM (MRIS), AND FOR OTHER PURPOSES" was passed into law on March 14, 2020;

WHEREAS, the aforementioned identification system aims to speed up and simplify processing of documents such as clearances, certifications, permits, licenses, tax payments and others as the information of the constituents in the city are readily available in the data information system;

WHEREAS, in order to properly implement the said Ordinance, certain provisions shall be amended to specify its primary implementing body, and the material to be used for the identification cards: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 6 of Ordinance No. 8619 is hereby amended and shall now read as follows:

"Sec. 6. One City ID Card Policy. – Every resident shall possess only one Manila Resident Information System card which may be a physical card or virtual card.

SEC. 2. Section 7 of Ordinance no. 8619 is hereby amended and shall now read as follows:

"Sec. 7. Issuance of a Manila Resident Identification System Card.

– All residents of the city, as certified by the validating office designated, shall be issued, upon clearance, an MRIS card bearing the name of the City Mayor as its authority and shall be the sole signatory of the ID card.

All MRIS cards shall be issued by the Electronic Data Processing (EDP) Services which shall be the primary implementing body of this Ordinance."

SEC. 3. Section 11 of Ordinance No. 8619 is hereby amended and shall now read as follows:

"Sec. 11. – Information to be contained in the Manila resident Information System Card. – The MRIS card shall contain the following information:

- Manila City Name, Seal and Logo
- Name of the Bearer
- Photo of the Bearer
- 4. Citizenship
- 5. Sex
- Blood Type
- 7. Address of the Bearer
- 8. Date of Birth of the Bearer
- Contact person in case of emergency
- 10. Name of Mother
- 11. Name of Father
- 12. Name of Wife/Husband
- Name of Children (if any)

- 14. Voter's ID reference
- 15. Date of MRIS Issuance and Validity
- 16. Unique Identification Number
- 17. Signature of the Bearer
- 18. Signature of the Authority (Mayor of the City)
- 19. Quick Response (QR) Code"

SEC. 4. Effectivity Clause. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 8, 2020.
