**ORDINANCE NO. 8690**

**AN ORDINANCE** APPROPRIATING SEVEN HUNDRED SIXTY-FOUR MILLION NINE HUNDRED TWENTY-FIVE THOUSAND PESOS (PHP. 764,925,000.00) AS SUPPLEMENTAL BUDGET NO. 18 FOR FISCAL YEAR 2020 FOR THE VARIOUS SOCIO-ECONOMIC PROGRAMS AND INFRASTRUCTURE PROJECTS OF THE CITY OF MANILA AND FOR OTHER PURPOSES

## PREAMBLE

WHEREAS, on 8 March 2020 Presidential Proclamation No. 922, s. 2020, was issued declaring a State of Public Health Emergency throughout the Philippines due to the Coronavirus Disease 2019 (COVID-19) and the Code Alert System for COVID-19 was raised to Code Red Sublevel Two (2) in accordance with the recommendation of the Department of Health (DOH) and the Inter-Agency Task Force for the Management of Emerging Infectious Diseases.

In view of the continuing rise of confirmed cases of COVID-19, the serious threat to the health, safety, security, and lives of our countrymen, the long-term adverse effects on their means of livelihood, and the severe disruption of economic activities, a state of national emergency is hereby declared over the entire country;

WHEREAS, said Presidential Proclamations enjoined all government agencies and Local Government Units (LGUs) to render full assistance to and cooperation with each other and mobilize the necessary resources to undertake critical, urgent, and appropriate disaster response aid and measures in a timely manner to curtail and eliminate the threat of COVID-19;

WHEREAS, no less than the 1987 Constitution provides that the state shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost and prioritizing, among others, the underprivileged, women and children (*Section 11, Article XIII, 1987 Philippine Constitution*);

WHEREAS, likewise, the Constitution upholds the conservation, promotion and popularization of the nation's historical and cultural heritage and resources, as well as the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature (*Section 15, Article XIV and Section 16, Article II, 1987 Philippine Constitution*);

WHEREAS, consistent with the Constitution, the City Government of Manila has espoused programs and projects for the benefit and welfare of the underprivileged, the women and the children of Manila. It has likewise initiated programs to conserve and promote Manila's cultural heritage, and promoted safety by improving public infrastructures;

WHEREAS, the Local Government Code of 1991, states that: *"Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants"* (Section 16 of Republic Act No. 7160),

WHEREAS, the same Code provides that all budgetary proposals shall be included and considered in the budget preparation process. After the local chief executive concerned shall have submitted the executive budget to the sanggunian, no ordinance providing for a supplemental budget shall be enacted, *except when supported by funds actually available as certified by the local treasurer or by new revenue sources.* (*Section 321 par 1 of Republic Act No 7160*),



WHEREAS, earlier today, the local legislative body approved Resolution No. 19, Series of 2020, adopted by the Executive Committee of the City Development Council on October 9, 2020, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM OR ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2020, TO COVER THE VARIOUS SOCIO-ECONOMIC PROGRAMS AND INFRASTRUCTURE PROJECTS OF THE CITY OF MANILA IN THE TOTAL AMOUNT OF SEVEN HUNDRED SIXTY-FOUR MILLION NINE HUNDRED TWENTY-FIVE THOUSAND PESOS (PHP. 764,925,000.00)": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1. Appropriations.** – The Supplemental Budget of the City Government of Manila for Fiscal Year 2020 in the amount of Seven Hundred Sixty-Four Million Nine Hundred Twenty-Five Thousand Pesos (PhP. 764,925,000.00) is hereby approved.

**SEC. 2. Source of Funds.** – The source of funds for the Supplemental Budget in the total amount of Seven Hundred Sixty-Four Million Nine Hundred Twenty-Five Thousand Pesos (PhP. 764,925,000.00) shall be derived from the following source:

**SEC. 3. Use of Funds.** – The amount of Seven Hundred Sixty-Four Million Nine Hundred Twenty-Five Thousand Pesos (PhP. 764,925,000.00) is hereby appropriated as follows:

a. Department of Social Welfare: Maintenance and Other Operating Expenses (MOOE) - Welfare Goods Expenses for the "Pamaskong Handog para sa Pamilyang Manileno" in the amount of Two Hundred Ten Million Pesos (PhP. 210,000,000.00);

b. Manila Health Department:

b.1. MOOE – Medical, Dental and Laboratory Supplies Expenses for the purchase of reagent kits for COVID-19 testing in the amount of Thirty-Two Million Pesos (PhP. 32,000,000.00).

b.2. "Dagdag Nutrisyon ni Nanay at Baby sa Panahon ng Pandemya" in the total amount of One Hundred Twenty-Two Million Five Hundred Twenty-Five Thousand Pesos (PhP. 122,525,000.00) with the following details:

- MOOE – One Hundred Twenty-Two Million Forty-Five Thousand Pesos (PhP. 122,045,000.00); and

- Capital Outlay – Four Hundred Eighty Thousand Pesos (PhP. 480,000.00).

c. Department of Engineering and Public Works – Capital Outlay – for the following:

c.1. BASECOMMUNITY and Baseco Road Development in the total amount of Two Hundred Forty-Three Million Pesos (PhP. 243,000,000.00);

c.2. Parks, Plazas and Monuments – Kartilya in the amount of Eight Million Four Hundred Thousand Pesos (PhP. 8,400,000.00);




c.3. Other Infrastructure Assets for the: (i) installation of lights and construction of plant boxes at Manila China Town in the amount of Forty-Four Million Pesos (PhP. 44,000,000.00); and (ii) installation of street signages, lanterns and posts at various roads within the City (Phase II) in the amount of Eighty-Five Million Pesos (PhP. 85,000,000.00); and

c.4. Buildings and Other Structures for the improvement of Arraque Market and Pritil Market in the total amount of Twenty Million Pesos (PhP. 20,000,000.00).


**SEC. 4. Effectivity Clause.** – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 15, 2020.


