ORDINANCE NO. 8698

AN ORDINANCE REALIGNING THE AMOUNT OF THREE MILLION ONE HUNDRED THREE THOUSAND PESOS (PHP. 3,103,000.00) UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES - TRAINING EXPENSES, REPAIR AND MAINTENANCE (BUILDING & OTHER STRUCTURES, FURNITURE AND FIXTURE AND OTHER PROPERTY, PLANT AND EQUIPMENT) AND RENT EXPENSES AUTHORIZED THROUGH ORDINANCE NO. 8585 - OTHERWISE KNOWN AS THE EXECUTIVE BUDGET OF FY 2020, TO BE TRANSFERRED TO MAINTENANCE AND OTHER OPERATING EXPENSES - CONSULTANCY SERVICES OF THE SAME OFFICE TO COVER THE PAYMENT OF SALARIES OF ADDITIONAL THIRTY-SIX (36) CONSULTANTS OF THE OFFICE OF THE MAYOR UNTIL DECEMBER 31, 2020

Be it ordained by the City Council of Manila, in session assembled, THAT:

Section 1. The realignment of Three Million One Hundred Three Thousand Pesos (PhP. 3,103,000.00) under the Maintenance and Other Operating Expenses - Training Expenses, Repair and Maintenance (Building & Other, Furniture and Fixture and Other Property, Plant and Equipment) and Rent Expenses authorized through Ordinance No. 8585 - otherwise known as the Executive Budget of FY 2020, to be transferred to Maintenance and Other Operating Expenses – Consultancy Services of the same office to cover the payment of salaries of additional thirty-six (36) consultants of the Office of the Mayor until December 31, 2020 is hereby authorized:
