AN ORDINANCE AUTHORIZING THE UPGRADING OF THE SALARY GRADE OF THE NURSE 1 ENTRY LEVEL POSITION IN THE MANILA HEALTH DEPARTMENT AND THE SIX (6) CITY HOSPITALS FROM SG 11 TO SG 15 AND MODIFYING THE POSITION ATTRIBUTES OF THE NEXT HIGHER NURSING POSITION TITLES PURSUANT TO REPUBLIC ACT NO. 9173 (PHILIPPINE NURSING ACT OF 2002) AND ITS IMPLEMENTING GUIDELINES UNDER DBM BUDGET CIRCULAR NO. 2020-04

PREAMBLE

WHEREAS, the Supreme Court of the Philippines has upheld with finality on 13 December 2019 the validity of Section 32 of Republic No. 9173, (otherwise known as the Philippine Nursing Act of 2020) which provides a minimum base pay of not lower than Salary Grade (SG)-15 for Nurses working in the public sector;

WHEREAS, the President, Rodrigo Roa Duterte, subjected the implementation of the salary adjustment of Nurses to the Department of Budget and Management (DBM) after the promulgation of the SC decision and which led to the issuance of DBM Budget Circular No. 2020-04 on 17 July 2020;

WHEREAS, the said Circular prescribed the Rules and Regulations on the upgrading of the entry-level of Nurse I position from SG-11 to SG-15, while at the same time, utilized administrative procedures for the consequential modification of the position attributes of the next higher Nurse items from Nurse II to Nurse VII;

WHEREAS, these necessary actions were taken by DBM in order to prevent the possibility of an unforeseen across-the-board adjustment of the SG level of all Nursing Positions which would wreak havoc on the budgetary outlay of national local government agencies for Personal Services in 2020 and beyond: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in special session assembled, THAT;

SECTION 1. Declaration of Policy. – It is hereby declared the policy of the City Government of Manila to comply with the prescribed rules and regulations contained under DBM Circular No. 2020-04 regarding the upgrading of the entry level and modifying the position attributes of Nurse Positions.

SEC. 2. Upgrading of Entry Level Position of Nurse. – The Salary Grade of the following classes of Nurse Positions are hereby upgraded in the Manila Health Department and the six (6) City Government Hospitals, as follows:

SEC. 4. Appropriation. – The amount necessary to implement this Ordinance shall be taken from existing and available funds appropriated for such purpose under the FY 2021 Executive Budget. Thereafter, all subsequent appropriations shall be integrated in the annual budget of the City of Manila.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on November 23, 2020.
