**ORDINANCE NO. 8704**

**AN ORDINANCE APPROPRIATING ONE HUNDRED THIRTY-FOUR MILLION ONE HUNDRED NINETY THOUSAND NINE HUNDRED PESOS (PHP. 134,190,900.00) AS SUPPLEMENTAL BUDGET NO. 19 FOR FISCAL YEAR 2020 FOR VARIOUS INFRASTRUCTURE PROJECTS WITHIN THE CITY OF MANILA**

## PREAMBLE

WHEREAS, no less than the 1987 Constitution provides that the state shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost and prioritizing, among others, the underprivileged, women and children (Section 11, Article XIII, 1987 Philippine Constitution);

WHEREAS, likewise, the Constitution upholds the conservation, promotion and popularization of the nation's historical and cultural heritage and resources, as well as the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature (Section 15, Article XIV and Section 16, Article II, 1987 Philippine Constitution);

WHEREAS, consistent with the Constitution, the City Government of Manila has continuously produced programs and projects for the benefit and welfare of the underprivileged, the women and the children of Manila. It has likewise initiated programs to conserve and promote Manila's cultural heritage, and promoted safety by improving public infrastructures;

WHEREAS, the Local Government Code of 1991, states that: *"Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants"* (Section 16 of Republic Act No. 7160);

WHEREAS, the same Code provides that all budgetary proposals shall be included and considered in the budget preparation process. After the local chief executive concerned shall have submitted the executive budget to the Sanggunian, no Ordinance providing for a supplemental budget shall be enacted, except when supported by funds actually available as certified by the local treasurer or by new revenue sources. (Section 321 of Republic Act No. 7160);

WHEREAS, the Local Legislative Body approved Resolution No. 22, Series of 2020, adopted by the Executive Committee of the City Development Council on 23 November 2020, entitled: **"A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2020 TO COVER VARIOUS INFRASTRUCTURE PROJECTS IN THE CITY OF MANILA"**: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

**SECTION 1. Appropriations.** – The Supplemental Budget of the City Government of Manila for Fiscal Year 2020 in the amount of One Hundred Thirty-Four Million One Hundred Ninety Thousand Nine Hundred Pesos (PhP. 134,190,900.00) is hereby approved.

**SEC. 2. Source of Funds.** – The source of funds for the Supplemental Budget in the total amount of One Hundred Thirty-Four Million One Hundred Ninety Thousand Nine Hundred Pesos (PhP. 134,190,900.00) shall be derived from the following source:

**New Revenue Source**

Patrimonial = Sale of Property PhP. 134,190,900.00

**SEC. 3. Use of Funds.** - The amount of One Hundred Thirty-Four Million One Hundred Ninety Thousand Nine Hundred Pesos (PhP. 134,190,900.00) is hereby appropriated with the following appropriations under the Department of Engineering and Public Works – Capital Outlay:

Capital Outlay	Amount
1. Other Land Improvements	PhP. 7,000,000.00
2. Other Infrastructure Assets	65,100,000.00
3. Buildings	31,500,000.00
4. Hospitals and Health Centers	6,356,900.00
5. Other Property, Plant and Equipment	24,234,000.00
<b>Total</b>	<b>PhP. 134,190,900.00</b>


**SEC. 4. Effectivity Clause.** – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on November 26, 2020.
