ORDINANCE NO. 8706

AN ORDINANCE AUGMENTING THE MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) OF THE OFFICE OF THE MAYOR – PUBLIC EMPLOYMENT SERVICE OFFICE IN THE AMOUNT OF FOURTEEN MILLION TWO HUNDRED FIFTY-ONE THOUSAND FOUR HUNDRED FORTY PESOS (PHP. 14,251,440.00) TO FUND THE FACE MASK PRODUCTION PROGRAM OF THE CITY OF MANILA THROUGH SAVINGS FROM THE MOOE ACCOUNTS OF VARIOUS DEPARTMENTS/OFFICES UNDER THE FY 2020 ANNUAL BUDGET

PREAMBLE

WHEREAS, the 1987 Constitution provides that the state shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost and prioritizing, among others, the underprivileged, women and children (Section 11, Article XIII, 1987 Philippine Constitution);

WHEREAS, consistent with the Constitution, the City Government of Manila have espoused programs and projects for the benefit and welfare of the underprivileged, the women and the children of Manila. It has likewise initiated programs to promote the safety of its citizenry and the general public;

WHEREAS, the Local Government Code of 1991, states that: "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants" (Section 16 of Republic Act No. 7160);

WHEREAS, the Local Government Code of 1991, provides that all budgetary proposals shall be included and considered in the budget preparation process. After the local chief executive concerned shall have submitted the executive budget to the sanggunian, no ordinance providing for a supplemental budget shall be enacted, except when supported by funds actually available as certified by the local treasurer or by new revenue sources. (Section 321 of Republic Act No. 7160);

WHEREAS, the Local Government Code also provides that "..the local chief executive or the presiding officer of the Sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations." (Section 321 of Republic Act No. 7160);

WHEREAS, earlier today, the local legislative body approved Resolution No. 24, Series of 2020, adopted by the Executive Committee of the City Development Council on 20 November 2020, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2020 BY AUGMENTING THE MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) OF THE OFFICE OF THE MAYOR – PUBLIC EMPLOYMENT SERVICE OFFICE IN THE AMOUNT OF FOURTEEN MILLION TWO HUNDRED FIFTY-ONE THOUSAND FOUR HUNDRED FORTY PESOS (P 14,251,440.00) TO FUND THE FACE MASK PRODUCTION PROGRAM OF THE CITY OF MANILA": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT;

SECTION 1. Augmentation. – The amount of Fourteen Million Two Hundred Fifty-One Thousand Four Hundred Forty Pesos (PhP. 14,251,440.00) shall be used to augment the MOOE account of the Office of the Mayor – Public Employment Service Office to implement the Face Mask Production Program of the City of Manila, as follows:

Total	PhP. 14,251,440.00

SEC. 2. Source of Funds. – The source of funds for such augmentation shall be derived from savings from the various MOOE accounts of departments/offices in the total amount of Fourteen Million Two Hundred Fifty-One Thousand Four Hundred Forty Pesos (PhP. 14,251,440.00), as follows:

- SEC. 3. Separability. If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.
- SEC. 4. Effectivity Clause. This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on November 26, 2020.
