## **ORDINANCE NO. 8707**

AN ORDINANCE CONVERTING ITEM NO. 192, WITH POSITION TITLE CHIEF ADMINISTRATIVE OFFICER V IN THE CITY GENERAL SERVICES OFFICE (CGSO) THROUGH THE SCRAP-AND-BUILD PROGRAM UNDER THE GOVERNMENT'S RATIONALIZATION PROGRAM AND CREATING ITEM NO. 3, WITH POSITION TITLE ATTORNEY IV UNDER THE SAME OFFICE

## **PREAMBLE**

WHEREAS, Section 325 (d) of the Local Government Code of 1991, provides that: "In cases of abolition of positions and the creation of new ones resulting from the abolition of existing positions in the career service, such abolition or creation shall be made in accordance with pertinent provisions of this code and the civil service law, rules and regulations" (Republic Act No. 7160);

WHEREAS, on 12 May 2006, the Executive Committee on the Rationalization Program composed of the Department of Budget and Management (DBM) and CSC, issued Resolution No. 1, providing that the scrap and build policy must be observed when new positions may be created as long as there are corresponding obsolete/unnecessary but funded positions which can be abolished to support the creation new ones;

WHEREAS, the generated savings from the collapsed positions shall not be less than the computed amount needed to fund the created positions and that the total amount for Personal Services, including the new positions, will not exceed the 45% statutory limitation on the total approved annual appropriation: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in special session assembled, THAT;

SECTION 1. Conversion of the Abolished Position. – Item No. 192, with position title Chief Administrative Officer V in the City General Services Office (CGSO) is hereby scrapped and converted to Item No. 3, with position title Attorney IV through the Scrap-and-Build Program under same office:

SEC. 2. Appropriation. – The amount necessary to implement this Ordinance shall be taken from existing and available funds sourced from the savings generated by the abolition of the aforementioned position to be incorporated in the FY 2021 Executive Budget. Thereafter, all subsequent appropriations shall be integrated in the Annual Budget of the City of Manila.

SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on December 3, 2020.
