## ORDINANCE NO. 8712

AN ORDINANCE AMENDING THE TITLE OF ORDINANCE NO. 8653, WHICH WAS ENACTED ON JULY 6, 2020 AND APPROVED BY THE CITY MAYOR ON SEPTEMBER 9, 2020, INCLUDING SECTION 1 AND SECTION 2 THEREOF

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. The title of Ordinance No. 8653, is hereby amended and shall now be read as follows:

"AN ORDINANCE ADOPTING THE NON-CAREER PRIMARILY CONFIDENTIAL POSITION TITLES OF THE PERSONAL STAFF OF THE MEMBERS OF SANGGUNIANG PANLUNGSOD NG MAYNILA, COTERMINOUS WITH THE TERM OF OFFICE OF THE APPOINTING AUTHORITY OR THE HEAD OF THE ORGANIZATIONAL UNIT/OFFICE WHERE ASSIGNED"

SEC. 2. Section 1 of Ordinance No. 8653, is hereby amended and shall be now read as follows:

"SECTION 1. The non-career primarily confidential position titles of the personal staff of the members of the Sangguniang Panlungsod ng Maynila to be adopted, coterminous with the term of office of the appointing authority or the head of organizational unit/office, will be as follows:"
