SECTION 1. Section 2A (Tricycle Terminals) of Ordinance No. 7755 is hereby furthermore amended, by including therein the loading and unloading areas of Paraiso Tricycle Operators and Driver's Association Brgy. 177, to read as follows:

"PARAISO TRICYCLE OPERATORS AND DRIVER'S ASSOCIATION BRGY. 177

Loading and Unloading Areas

- 1. Loading - a. Clemente St. - Hermosa St. (vice versa)
- 2. Unloading - a. Flora
b. Juan Luna"

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended by including therein the Route Measure Capacity and authorized route line of Paraiso Tricycle Operators and Driver's Association Brgy. 177, to read as follows:

"ASSOCIATION

ROUTE

The authorized route line of operation shall be via Clemente Street - Flora Street - Juan Luna Street - Hermosa Street and vice-versa."




