**ORDINANCE NO. 8760**

**AN ORDINANCE** AMENDING CHAPTER 7, SECTION 37 OF ORDINANCE NO. 8754, ENTITLED: "AN ORDINANCE PROVIDING FOR THE STREAMLINED PROCEDURES FOR THE ISSUANCE OF LOCAL BUSINESS LICENSES, CLEARANCES, PERMITS, CERTIFICATIONS OR AUTHORIZATIONS IN THE CITY OF MANILA PURSUANT TO RULE IX OF THE IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 11032, OTHERWISE KNOWN AS THE "EASE OF DOING BUSINESS AND EFFICIENT GOVERNMENT SERVICE DELIVERY ACT OF 2018" AND FOR OTHER PURPOSES"

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Chapter 7, Section 37 of Ordinance No. 8754, is hereby amended and shall now read as follows:

**“SEC. 37. Rate of Fees to be Collected. –** The rate of fees to be collected the City Treasurer’s Office for the issuance of Barangay Clearance for Business Permit and Barangay Clearance for Locational Clearance (as a requirement for Building Permit), shall be in accordance with the rates fixed by the enacted Barangay Ordinance of the concerned Barangay. Nevertheless, each barangay reminded to adopt, update or adjust its own Barangay Revenue Ordinance whenever necessary and comply with the guidelines set in R.A. 11032 and by the DILG and DOF in DILG-DOF Joint Memorandum Circular No. 2019-01 dated 17 May 2019 and subsequent related issuances.

In conformity with the guiding principles laid down in R.A. 11032 and DILG-DOF Joint Memorandum Circular No. 2019-01, it is hereby recommended that the Barangay Clearance Fee may be imposed by each Barangay shall not exceed Five Hundred Pesos (PhP. 500.00).

Should there be a Barangay that fails to adopt, update or adjust its own Barangay Revenue Ordinance in compliance with R.A. 11032 and DILG-DOF Joint Memorandum Circular No. 2019-01 dated 17 May 2019 and subsequent related issuances, the City shall, in the interim period, collect a Barangay Clearance Fee of Five Hundred Pesos (PhP. 500.00) for the Barangay Clearance issued for the said Barangay, pending the eventual compliance of the Barangay concerned.

All Barangay Ordinances issued by the barangays in relation to the imposition of Barangay Clearance Fees shall be subject to the City’s power of review under Section 57 of the Local Government Code of 1991. Rates for barangay clearance and permits for specific document, other activities not related to doing business, or the use of barangay facilities shall be left to the sound discretion of each barangay.

**SEC. 2. Effectivity Clause. –** This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on June 17, 2021.
