ORDINANCE NO. 8762

AN ORDINANCE AMENDING THE TITLE AND SECTION 1 OF ORDINANCE NO. 8594, BY CHANGING THE NAME OF THE FRANCHISEE FROM UNITED ASSOCIATION OF COCKPIT OWNERS AND OPERATORS OF THE PHILIPPINES, INCORPORATED TO LUCKY 8 STAR QUEST INC., THE FORMER HAVING AN EXISTING FRANCHISE IN THE CITY OF MANILA BUT TRANSFERRED ITS ENTIRE BUSINESS OPERATION TO LUCKY 8 STAR QUEST INC., WHICH HAS VAST MANPOWER RESOURCES TO ACCOMMODATE THE LEGAL REQUIREMENTS OF THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION

PREAMBLE

WHEREAS, on 14 November 2019, the City Council of Manila enacted Ordinance No. 8594, Granting Franchise to United Association of Cockpit Owners and Operators of the Philippines, Incorporated, to broadcast live and data streamed cockfighting activities and derbies at commercial establishments and to establish, operate and maintain off-site cockpit betting station within the City of Manila;

WHEREAS, on 1 July 2021, Mr. Manuel M. Zarcal, Assistant Secretary to the Mayor, submitted a letter to the City Council of Manila, forwarding therewith the request of United Association of Cockpit Owners and Operators of the Philippines, Incorporated to amend Ordinance No. 8594 to reference their change of name to Lucky 8 Star Quest Inc.: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. The Title of Ordinance No. 8594 is hereby amended, and shall now read as follows:

**“AN ORDINANCE GRANTING FRANCHISE TO
LUCKY 8 STAR QUEST INC., TO BROADCAST LIVE AND
DATA STREAMED COCKFIGHTING ACTIVITIES AND
DERBIES AT COMMERCIAL ESTABLISHMENTS AND TO
ESTABLISH, OPERATE AND MAINTAIN OFF-SITE
COCKPIT BETTING STATION WITHIN THE CITY OF
MANILA”**

SEC. 2. Section 1 of Ordinance No. 8594 is hereby amended, and shall now read as follows:

“SECTION 1. Nature, Scope, Grant of Franchise. –
Subject to the provisions of applicable laws, rules and regulations, a franchise to broadcast live and data stream cockfighting activities and derbies at commercial establishment such as bars, club, restaurant and the likes, within the City of Manila is hereby granted to **Lucky 8 Star Quest Inc.**, provided that the cockfighting subject to broadcast shall only be done in a licensed cockpit, unless otherwise allowed in some other area, pursuant to Presidential Decree No. 449.”

SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on July 5, 2021.


