## **ORDINANCE NO. 8765**

AN ORDINANCE AUGMENTING THE VARIOUS ACCOUNTS UNDER THE FY 2021 ANNUAL BUDGET FROM SAVINGS AND FOR OTHER PURPOSES

## **PREAMBLE**

WHEREAS, the FY 2021 Annual Budget appropriated funds for various items under the Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) Accounts;

WHEREAS, after due consideration, there is a need to augment various accounts under the FY 2021 Annual Budget from savings within the same expense class to ensure the effective and efficient delivery of priority programs and projects of the City of Manila;

WHEREAS, the City Treasurer and the City Accountant have issued the Certificate of Availability of Funds/Declaration of Savings as supporting document for such augmentation through savings;

WHEREAS, Section 336 of Republic Act No. 7160, or the Local Government Code of 1991, Use of Appropriated Funds and Savings, provides that funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;

WHEREAS, the City Council approved Resolution No. 14, Series of 2021, of the Executive Committee of the City Development Council, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND THE ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2021 IN RELATION TO THE AUGMENTATION OF VARIOUS ACCOUNTS UNDER THE FY 2021 ANNUAL BUDGET THROUGH SAVINGS FROM THE SAME EXPENSE CLASS": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Augmentation. – The following items under the Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay Accounts of the FY 2021, Annual Budget shall be augmented through savings from the PS, MOOE and CO accounts, respectively:

Under PS, the Representation and Transportation Allowance shall be used for the newly created positions under the MUSO.

For MOOE, the Other General Services will be used for the Special Program for the Employment of Students and Government Internship Program of the Office of the Mayor – PESO while the Security Services under the CGSO will be used for the security needs of City parks and facilities.

As to the Capital Outlay, the Parks, Plazas and Monuments under the DTCAM – FY 2021 Annual Budget covers various parks, plazas and monuments in the City of Manila.

SEC. 2. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.
