AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 9, SERIES OF 2021, TO FUND THE BASECO COMMUNITY HOSPITAL AND THE MANILA E-CITIZENS AND E-SERVICES SYSTEM OF THE CITY OF MANILA IN THE TOTAL AMOUNT OF ONE HUNDRED NINETY-FIVE MILLION NINE HUNDRED SEVENTY-EIGHT THOUSAND PESOS (PHP. 195,978,000.00) AND FOR OTHER PURPOSES

PREAMBLE

WHEREAS, every local government unit shall exercise the powers that are essential to the promotion of the general welfare. It shall ensure and support, among other things, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, the enhancement of economic prosperity and social justice, and preserve the comfort and convenience of its inhabitants [Section 16 of Republic Act (R.A.) No. 7160 or the Local Government Code of 1991];

WHEREAS, a supplemental budget may be enacted when supported by funds actually available as certified by the local treasurer or by new revenue sources (Section 321, of R.A. No. 7160);

WHEREAS, the City Council likewise approved Resolution No. 15, Series of 2021 of the Executive Committee of the City Development Council, entitled "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND THE ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2021 FOR THE BASECO COMMUNITY HOSPITAL AND THE MANILA E-CITIZENS AND E-SERVICES SYSTEM OF THE CITY OF MANILA IN THE TOTAL AMOUNT OF ONE HUNDRED NINETY-FIVE MILLION NINE HUNDRED SEVENTY-EIGHT THOUSAND PESOS (PHP. 195,978,000.00)": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Appropriations. – The FY 2021 Supplemental Budget of the City of Manila in the total amount of One Hundred Ninety-Five Million Nine Hundred Seventy-Eight Thousand Pesos (Php. 195,978,000.00) is hereby appropriated to fund the following Capital Outlays of the City of Manila, as follows:
