AN ORDINANCE CREATING TEN (10) NEW PLANTILLA ITEMS OF TRAFFIC AIDE I UNDER THE MANILA TRAFFIC AND PARKING BUREAU, PROVIDING FUNDS NECESSARY THEREFOR AND FOR OTHER PURPOSES

PREAMBLE

WHEREAS, the requesting agency, Manila Traffic and Parking Bureau (MTPB), has certified the pressing need to augment the MTPB's current thirty-six (36) Traffic Aide regular items from the existing seven hundred forty-four (744) Job Order traffic enforcers, many of whom rightfully deserve to be regularized after more than a decade of outstanding performance in the line of duty;

WHEREAS, the City Budget Office has favorably issued its Recommendation for the passage of the necessary Ordinance to effect the creation of the identified positions estimated at a total cost of One Million Six Hundred Twenty-Eight Thousand Six Hundred Forty Pesos (PhP. 1,628,640.00), bases on the 2021 Authorized Rate of the ten (10) Traffic Aide I items: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Declaration of Policy. – It is hereby declared the policy of the City Government of Manila to faithfully observe the overriding goal of improving the delivery of vital services in terms of quality, scope, speed, accountability and affordability.

The city and its instrumentalities must promote focused use of limited resources on core functions and programs.

SEC. 2. New Plantilla Positions. – The following new Plantilla Items are hereby created under the Manila Traffic and Parking Bureau (MTPB):

SEC. 3. Qualifications, Powers and Duties/Responsibilities. – The qualifications, powers, duties and responsibilities of the herein enumerated positions shall be based on the provisions of the Local Government Code, Civil Service Commission (CSC) and other relevant laws.

SEC. 4. Appointment. – The employment and appointment for those who will be occupying the herein subject positions shall be within the prescribed qualification standards and guidelines set forth by the Civil Service Commission (CSC) and other relevant agencies.


SEC. 5. Appropriation. – The amount necessary for the creation of the ten (10) new regular positions shall be sourced from available funds not otherwise appropriated and existing in the current budget of the City Government of Manila as certified by the City Budget Office and Office of the City Accountant. Thereafter, the herein subject positions shall be automatically funded through the succeeding Annual City Budget as part of the Plantilla of Personnel of the Manila Traffic and Parking Bureau.

SEC. 6. Effectivity. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on September 6, 2021.
