AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 10, SERIES OF 2021 FOR THE SEWERAGE WASTE WATER TREATMENT PLANT AT THE VETERINARY INSPECTION BOARD IN THE AMOUNT OF FORTY-THREE MILLION PESOS (PHP. 43,000,000.00) AND FOR OTHER PURPOSES

PREAMBLE

WHEREAS, every local government unit shall exercise the powers that are essential to the promotion of the general welfare. It shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants [Section 16 of Republic Act (R.A.) No. 7160 or the Local Government Code of 1991];

WHEREAS, a supplemental budget may be enacted when supported by funds actually available as certified by the local treasurer or by new revenue sources (Section 321 of R.A. No. 7160);

WHEREAS, the City Council likewise approved Resolution No. 17, Series of 2021 of the Executive Committee of the City Development Council on September 23, 2021, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND THE ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2021 FOR THE SEWERAGE WASTE WATER TREATMENT PLANT AT THE VETERINARY INSPECTION BOARD IN THE AMOUNT OF FORTY-THREE MILLION PESOS (PHP. 43,000,000.00)": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Appropriations. - The FY 2021 Supplemental Budget of the City of Manila in the amount of Forty-Three Million Pesos (PhP. 43,000,000.00) is hereby appropriated to fund the following project of the City of Manila, to wit:

- SEC. 2. Separability Clause. If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.
- SEC. 3. Effectivity Clause. This Ordinance shall take effect immediately upon its approval.
