ORDINANCE NO. 8784

AN ORDINANCE AMENDING ORDINANCE NO. 8304, BY SUBSTITUTING THE NAME OF THE NEWLY FORMED CORPORATION AS "MASBATES DOMINGO SANTIAGO ALTURAS TRICYCLE OPERATOR'S AND DRIVER'S ASSOCIATION INC."

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. The name of the Association in Ordinance No. 8304 is hereby amended and read as "Masbates Domingo Santiago Alturas Tricycle Operator's and Driver's Association Inc." as per Certificate of Incorporation No. CN202010433, dated 27 November 2020 after its former identity has been revoked by the Securities and Exchange Commission (SEC) due to non-compliance with the submission of SEC reportorials.

- SEC. 2. All other provisions of the old Ordinance shall remain in full force and effect, more particularly, its designated loading and unloading areas, as well as Route Measure Capacity (RMC).
- **SEC. 3. Separability Clause.** If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- **SEC. 4. Effectivity Clause**. This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 21, 2021.
