ORDINANCE NO. 8790

AN ORDINANCE AUTHORIZING THE REVERSION TO THE GENERAL FUND OF THE TOTAL AMOUNT OF FIFTY-ONE MILLION THREE HUNDRED FOURTEEN THOUSAND THIRTY-TWO PESOS (PHP. 51,314,032.00) UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES AND CAPITAL OUTLAY APPROPRIATIONS OF FY 2021 AND CAPITAL OUTLAY APPROPRIATIONS OF FY 2015 AND FY 2020 AND FOR OTHER PURPOSES

PREAMBLE

WHEREAS, Section 322 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 categorically provides:

"Section 322. Reversion of Unexpended Balances of Appropriations, Continuing Appropriations. – Unexpended balances of appropriations authorized in the annual appropriations ordinance shall revert to the unappropriated surplus of the general fund at the end of the fiscal year and shall not thereafter be available for the expenditure except by subsequent enactment. However, appropriations for capital outlays shall continue and remain valid until fully spent, reverted or the project is completed. Reversions of continuing appropriations shall not be allowed unless obligations therefor have been fully paid or otherwise settled.

The balances of continuing appropriations shall be reviewed as part of the annual budget preparation and the Sanggunian concerned may approve, upon recommendation of the local chief executive, the reversion of funds no longer needed in connection with the activities funded by said continuing appropriations subject to the provisions of this Section."

WHEREAS, amounts were appropriated for certain programs and projects under the Maintenance and Other Operating Expenses (MOOE) and Capital Outlay Accounts for FY 2021 and Capital Outlay account for FYs 2015 and 2020 Annual Budgets. However, due to changing circumstances, it was determined that said programs and projects are no longer necessary;

WHEREAS, for Fiscal Year 2021, there are priority programs and projects which need urgent funding through the enactment of a Supplemental Budget: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Reversion. – The following funds under the MOOE and Capital Outlay Appropriations for FY 2021 and Continuing Capital Outlay Appropriations accounts for FYs 2015 and 2020 are hereby reverted to the General Fund, to wit:
