AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 11, SERIES OF 2021 TO FUND THE VARIOUS CAPITAL OUTLAYS OF THE CITY OF MANILA IN THE AMOUNT OF FIFTY-ONE MILLION THREE HUNDRED FOURTEEN THOUSAND THIRTY-TWO PESOS (Php. 51,314,032.00) AND FOR OTHER PURPOSES.

PREAMBLE

WHEREAS, every local government unit shall exercise the powers that are essential to the promotion of the general welfare. It shall ensure and support, among other things, the enhancement of economic prosperity and social justice, and preserve the comfort and convenience of its inhabitants [Section 16 of Republic Act (R.A.) No. 7160 or the Local Government Code of 1991];

WHEREAS, a supplemental budget may be enacted when supported by funds actually available as certified by the local treasurer or by new revenue sources (Section 321, of R.A. No. 7160);

WHEREAS, the City Council likewise approved Resolution No. 21, Series of 2021 of the Executive Committee of the City Development Council, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2021 FOR THE VARIOUS CAPITAL OUTLAYS OF THE CITY OF MANILA IN THE AMOUNT OF FIFTY-ONE MILLION THREE HUNDRED FOURTEEN THOUSAND THIRTY-TWO PESOS (PhP. 51,314,032.00)": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Appropriations. – The FY 2021 Supplemental Budget of the City of Manila in the total amount of Fifty-One Million Three Hundred Fourteen Thousand Thirty-Two Pesos (PhP. 51,314,032.00) is hereby appropriated to fund the following program and project of the City of Manila, to wit;

SEC. 2. Separability Clause. – If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SEC. 3. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.
