ORDINANCE NO. 8799

AN ORDINANCE AUTHORIZING THE GRANT OF THE FISCAL YEAR 2021 SERVICE RECOGNITION INCENTIVE FOR GOVERNMENT EMPLOYEES PURSUANT TO ADMINISTRATIVE ORDER NO. 45, S. 2021, AND PROVIDING FUNDS THEREFOR IN THE AMOUNT OF NINETY-ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP. 91,500,000.00) AND FOR OTHER PURPOSES

PREAMBLE

WHEREAS, on December 24, 2021, President Rodrigo Roa Duterte issued Administrative Order (AO) No. 45, Series of 2021, authorizing the grant of Service Recognition Incentive to Government Employees for Fiscal Year (FY) 2021;

WHEREAS, as mentioned in AO No. 45 "it is imperative to provide reasonable incentives and assistance to our public servants, who are impacted not only by the pandemic, but also by various natural calamitites";

WHEREAS, Section 6 of AO No. 45 provides the guidelines for the grant of SRIs to Local Government Employees as follows:

- "a. The grant of one-time SRI to employees in LGUs, including those in the barangays, shall be determined by their respective sanggunians depending on the LGU's financial capability, subject to the PS Limitation in LGU budgets under RA No. 7160 or the "Local Government Code of 1991" and the conditions set forth in Section 2 hereof, at a uniform rate not exceeding Ten Thousand Pesos (₱10,000.00), chargable against their respective FY 2021 local government funds. Should the identified funding source prove insufficient to cover the maximum allowable rate of the SRI a lower but uniform amouint shall be paid to all qualified employees of the LGU; and
- b. In determining the amount of SRI, the sangguians shall exercise prudence and judicious use of government funds, ensuring that the expenditure is reasonable and will not, in any way, adversely affect the delivery of services to the public.";

WHEREAS, Section 336 of the Local Government Code states that funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing the transfer of appropriations from one item to antoher. However, the local chief executive or the presiding officer of the sangguian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respectiv offices from savings in other items within the same expense class of their respective approprioations;

WHEREAS, the local legislative body approved Resolution No. 25, adopted by the Executive Committee on the City Development Council on 28 December 2021, entitled "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND THE ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2021 FOR THE GRANT OF THE FY 2021 SERVICE RECOGNITION INCENTIVE (SRI) FOR GOVERNMENT EMPLOYEES PURSUANT TO ADMINISTRATIVE ORDER NO. 45 S. 2021": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Service Recognition Incentive. – The grant of one-time Service Recognition Incentive for FY 2021 not exceeding Ten Thousand Pesos (PhP. 10,000.00) to government employees is hereby authorized subject to the conditions under Administrative Order No. 45, s. 2021.

SEC. 2. Source of Funds. – The Service Recognition Incentive in the total amount of Ninety-One Million Five Hundred Thousand Pesos (PhP. 91,500,000.00) shall be funded by augmenting the Special Activities Fund-Personal Services (SAF-PS) Account from Personal Service savings under the FY 2021 Annual Appropriations Ordinance.

Attached and made an integral part hereof are the following details:

Annex A – Declaration of Savings under PS for Augmentation of Funds;
Annex B – Budgetary Requirement for the Service Recognition Incentive for FY 2021 under the SAF-PS.

SEC. 3. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

On the motion presented by the Honorable Macario M. Lacson, which was duly seconded by all those present, this Ordinance was finally approved for third and final reading by the City Council of Manila on December 29, 2021.
