**ORDINANCE NO. 8801**

**AN ORDINANCE FURTHERMORE AMENDING SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED BY ORDINANCE NO. 8405, BY INCREASING THE ROUTE MEASURE CAPACITY (RMC) OF SM SAN LAZARO, M. HIZON, LACSON, FELIX HUERTAS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED (SMSLMHILACFELTODA)**

Be it ordained by the City Council of Manila, in session assembled, **THAT:**

**SECTION 1.** Section 2 of Ordinance No. 7871, as amended by Ordinance No. 8405 is hereby furthermore amended by increasing the Route Measure Capacity (RMC) from 75 to 120 units of SM SAN LAZARO, M. HIZON, LACSON, FELIX HUERTAS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED (SMSLMHILACFELTODA), to read as follows:

SM San Lazaro, M. Hizon, Lacson, Felix Huertas, Tricycle Operators and Drivers Association, Incorporated (SMSLMHILACFELTODA)	SM San Lazaro - M. Hizon St. - LacsonSt- Felix Huertas St.	120 units"


The authorized routine of the additional units shall be as indicated in Section 2 of Ordinance No. 7871, as follows:

**SM San Lazaro, M. Hizon Street, Lacson Street, Felix Huertas Street and Vice Versa.**

**SEC. 2. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 13, 2022.


