ORDINANCE NO. 8801

AN ORDINANCE FURTHERMORE AMENDING SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED BY ORDINANCE NO. 8405, BY INCREASING THE ROUTE MEASURE CAPACITY (RMC) OF SM SAN LAZARO, M. HIZON, LACSON, FELIX HUERTAS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED (SMSLMHILACFELTODA)

Bo it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2 of Ordinance No. 7871, as amended by Ordinance No. 8405 is hereby furthermore amended by increasing the Route Measure Capacity (RMC) from 75 to 120 units of SM SAN LAZARO, M. HIZON, LACSON, FELIX HUERTAS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED (SMSLMHILACFELTODA), to read as follows:

"ASSOCIATION ROUTE RMC SM San Lazaro, M. Hizon, SM San Lazaro -120 units" Lacson, Felix Huertas. M. Hizon St. -Tricycle Operators and LacsonSt.-Drivers Association, Incorporated Felix Huertas St. (SMSLMHILACFELTODA)

The authorized routine of the additional units shall be as indicated in Section 2 of Ordinance No. 7871, as follows:

SM San Lazaro, M. Hizon Street, Lacson Street, Felix Huertas Street and Vice Versa.

SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 13, 2022.
